(1) Standalone SAR test exclusion for 100 MHz to 6 GHz at test separation distances ≤ 50mm

(Threshold<sub>1-g;10-g</sub>) ×  $d_{seperation} / f^{0.5}$ 

where

Threshold<sub>1-g;10-g</sub> is 3 for 1-g; 7.5 for 10-g

d<sub>seperation</sub> is the min. test separation distance; 5mm is used if the distance is less is the RF channel transmit frequency
