1 MFB

Answer/End Calls	Single click MFB
Reject Calls	Press MFB for 1s
Get far phone	Quickly tap MFB twice
Play/Pause	Single click MFB under music play status

2 LED Indicator

Pairing status: Red and blue light flashing alternately
 Pairing successfully: Light turns off
 Charging status: Red light keeps on
 Charging complete: Red light change blue light, then turns off
 Low battery: Red light turns on with indicate voice

3 Volume+/pre track/Mute switch

Volume+	Single click "V+"
Next Track	Press "V+" for 2s
Mute On/Off	Press "V+" for 2s switch during a call

4 Volume-/next track

Volume-	Single click "V-"
Previous Track	Press "V-" for 2s

5 ON/OFF

Power On	Roll the switch to the "ON" side red and blue light blink alternately
Power Off	Roll the switch to the "OFF" side red light keep on and turns off
