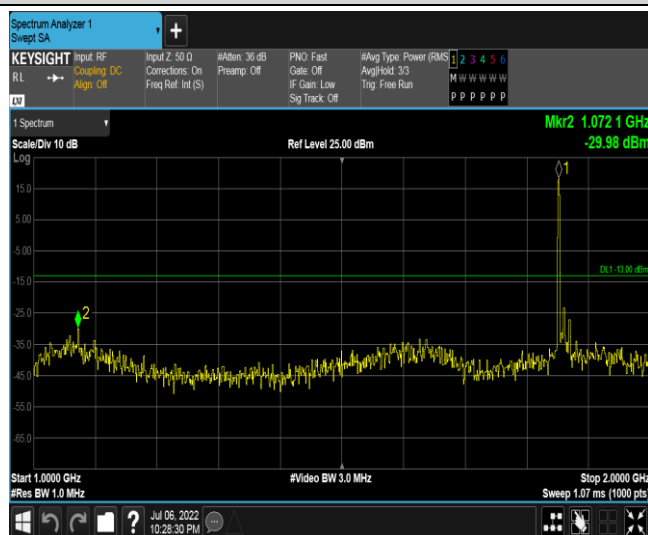

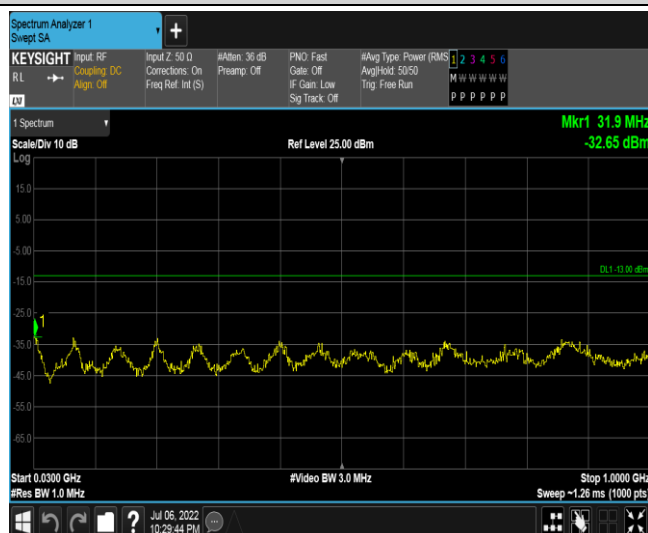

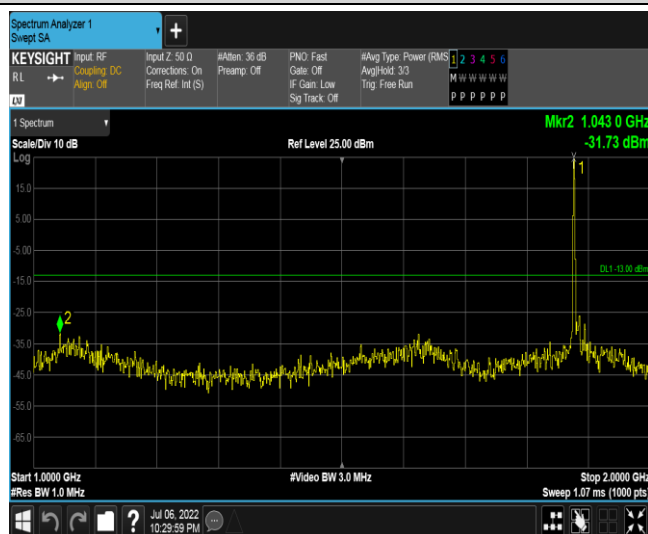

Band2-10MHz-16QAM-18900-1RB#0-Range2:1000~2000MHz

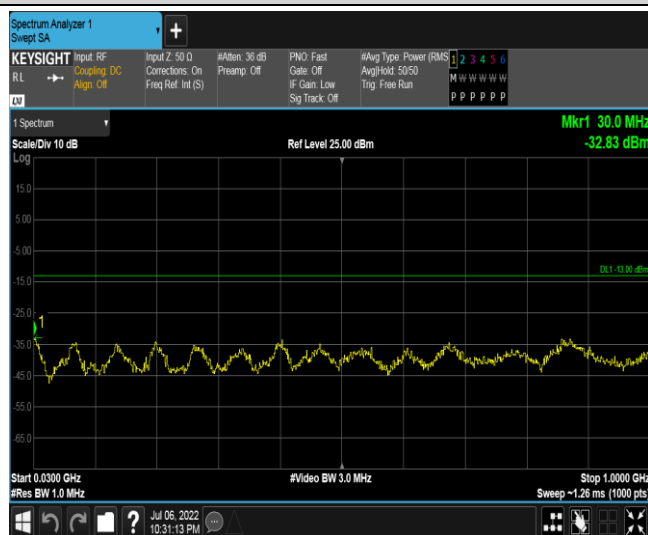

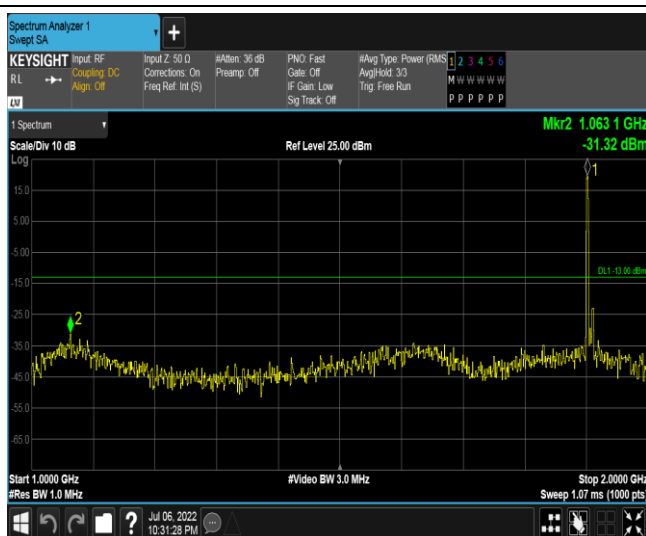

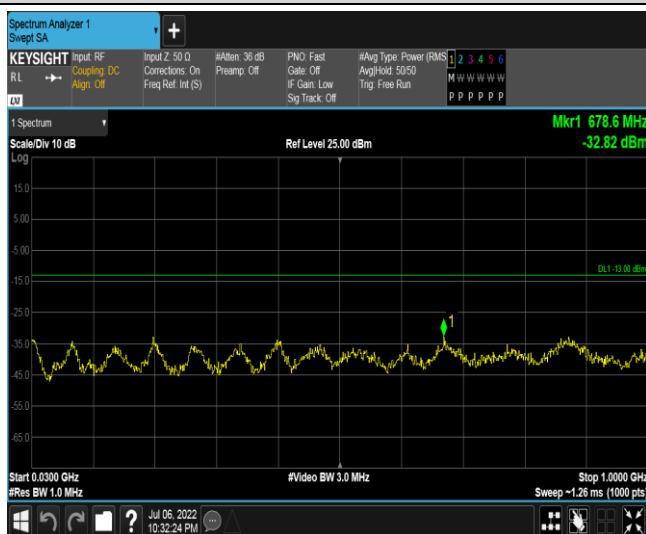

Band2-10MHz-16QAM-19150-1RB#0-Range3:2000~20000MHz

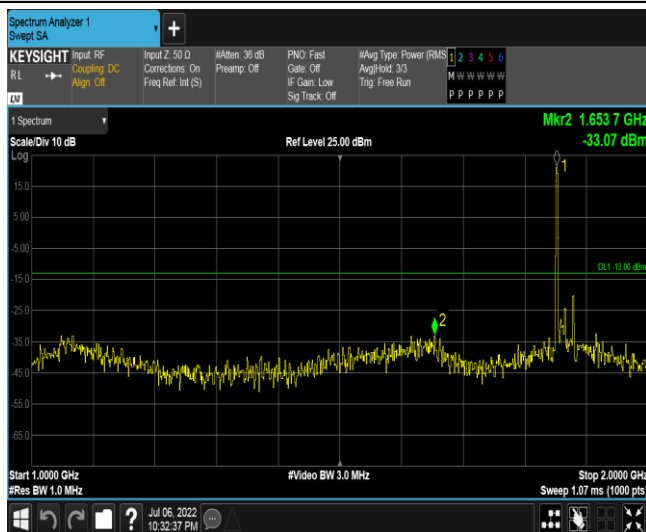
