




3. Operation Guide

(1) Power/Source:

- · Short press to switch audio mode, switching order: Bluetooth Mode TF Mode USB Sound Card Mode (TYPE-C Data Cable Connection) AUX Mode (Speaker will preserve pre-shutdown audio mode after speaker is powered off)

(2) Play/Pause/ *:

- · Short press to pause or play music. (Note: In AUX mode, short press the button to mute the speaker.)
- · When the speaker is connected to a Bluetooth device, long press for 2s to disconnect the connected Bluetooth device and enter Bluetooth pairing mode.

- · Short press to decrease the volume. In Bluetooth, TF card and USB sound card mode, long press to switch to the previous song.

 (4) Volume + / Next:
- · Short press to increase the volume. In Bluetooth, TF card and USB sound card mode, long press to switch to the next song.
- Standby indicator: Bluetooth Mode/Orange light TF Mode/Orange light USB Sound Card Mode (TYPE-C Data Cable Connection)/Orange light AUX Mode/Orange light .Audio source being switched, the orange indicator light flashes slowly. 
