Note 1: Test distance for frequencies at or above 30 MHz, measurements may be performed at a distance other than the limit distance provided they are not performed in the near field and the emissions to be measured can be detected by the measurement equipment. When performing measurements at a distance other than that specified, the results shall be extrapolated to the specified distance using an extrapolation factor of 20 dB/decade (inverse of linear distance for field-strength measurements, inverse of linear distance-squared for power-density measurements).

Note 2: Test distance for frequencies at below 30 MHz, measurements may be performed at a distance closer than the EUT limit distance; however, an attempt should be made to avoid making measurements in the near field. When performing measurements below 30 MHz at a closer distance than the limit distance, the results shall be extrapolated to the specified distance by either making measurements at a minimum of two or more distances on at least one radial to determine the proper extrapolation factor or by using the square of an inverse linear distance extrapolation factor (40 dB/decade). The test report shall specify the extrapolation method used to determine compliance of the EUT.

Note 1: If the peak output power procedure is used to measure the fundamental emission power to demonstrate compliance to requirements, then the peak conducted output power measured within any 100 kHz outside the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum measured in-band peak PSD level.

Note 2: If the average output power procedure is used to measure the fundamental emission power to demonstrate compliance to requirements, then the power in any 100 kHz outside of the authorized frequency band shall be attenuated by at least 30 dB relative to the maximum measured in-band average PSD level.

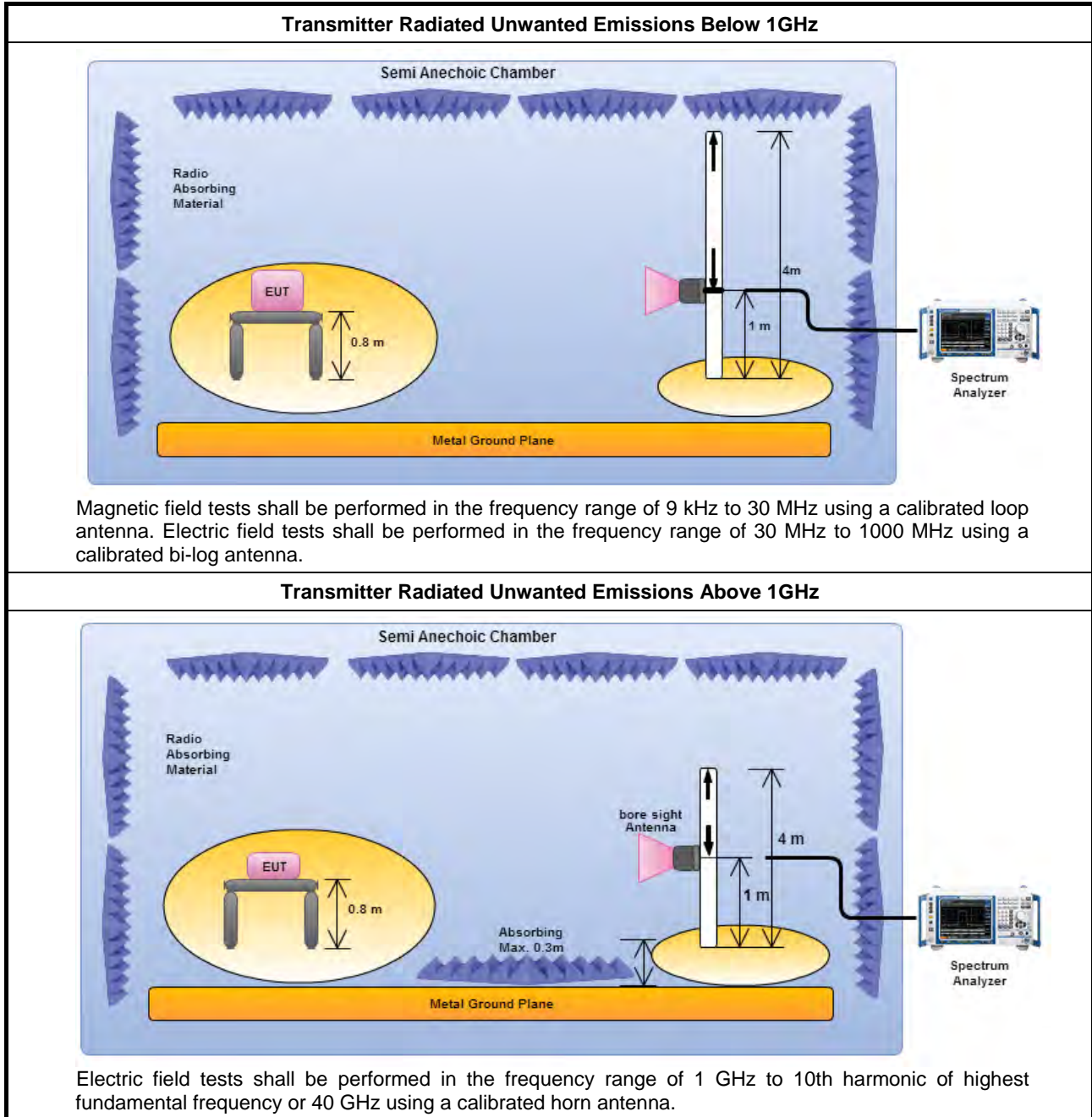

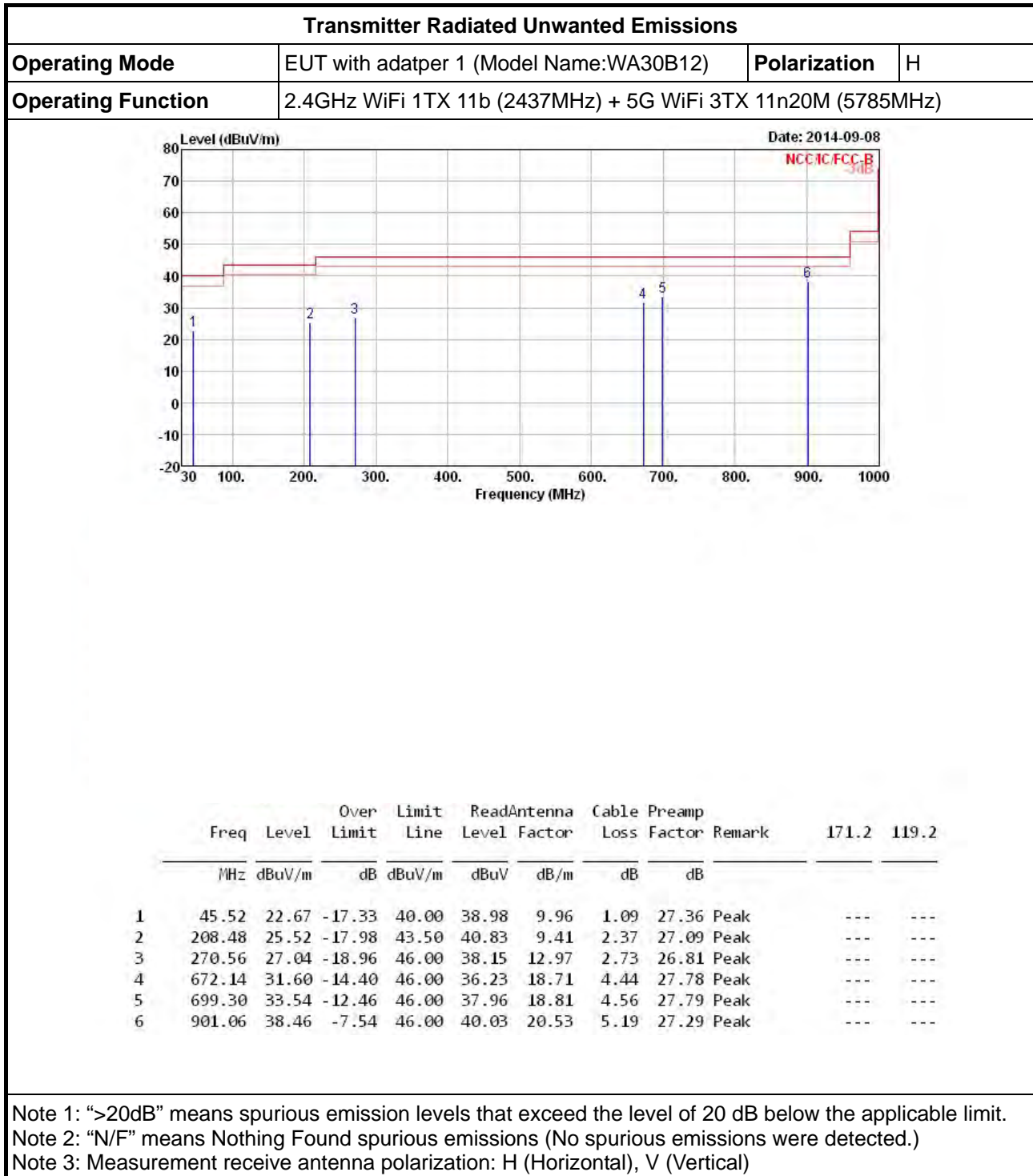

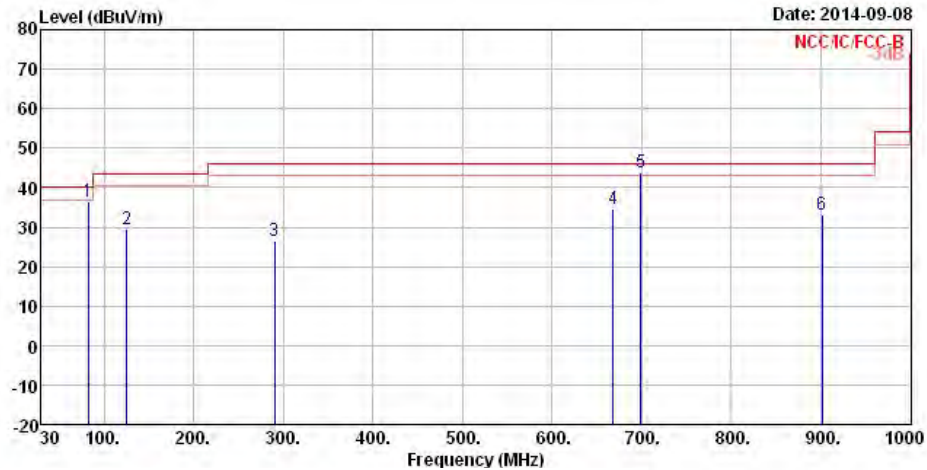
All amplitude of spurious emissions that are attenuated by more than 20 dB below the permissible value has no need to be reported.

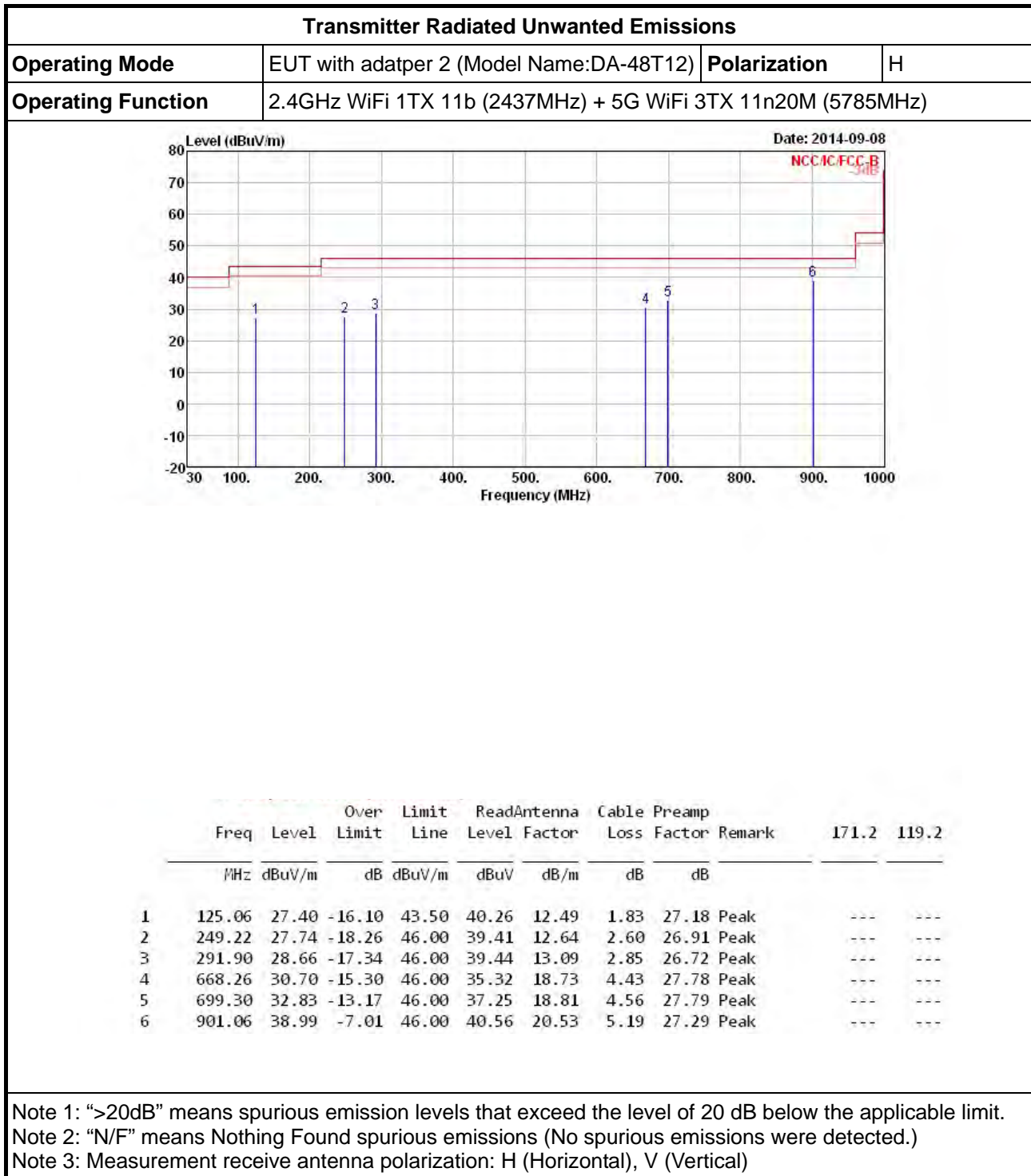

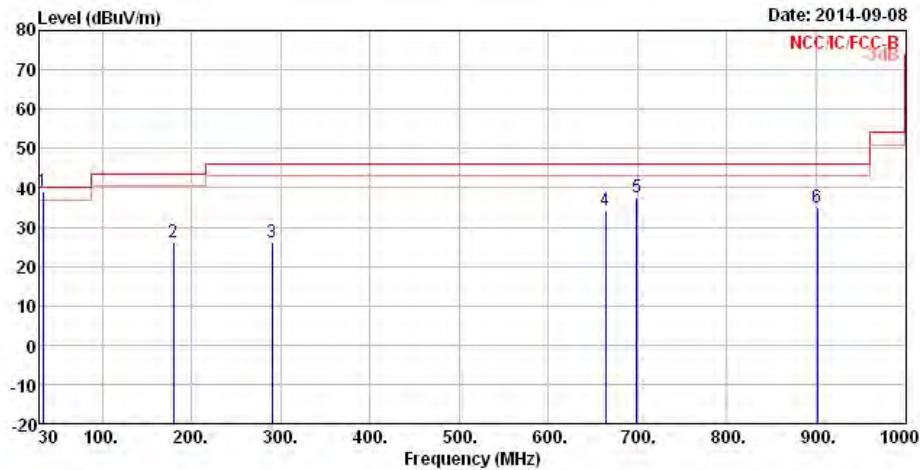

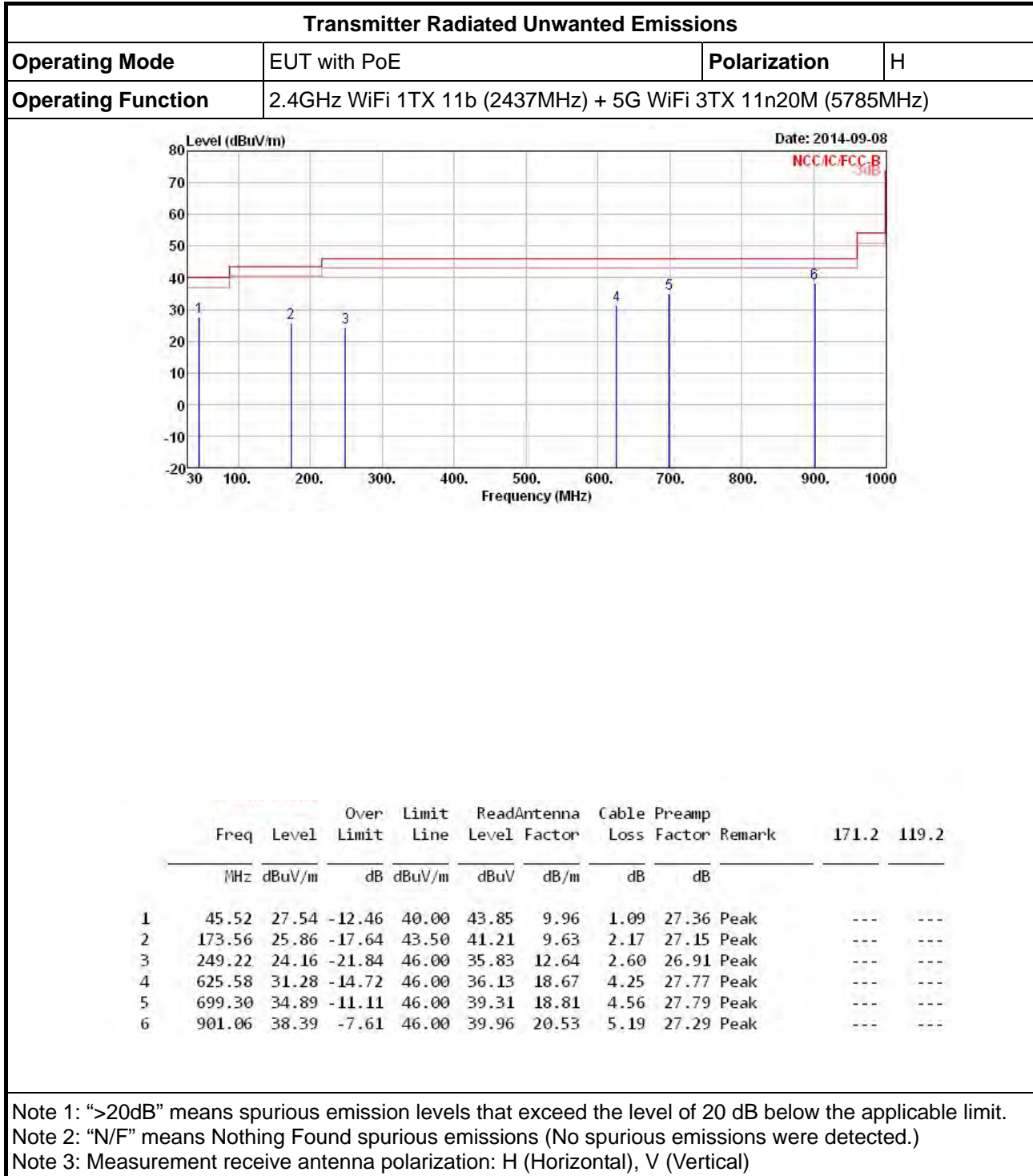
