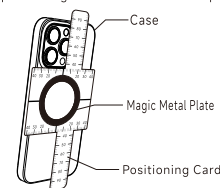
Magic Metal Plate Installation

- A.** Wireless Charging Smartphones(without casex**)
Non Wireless Charging Smartphones(without casex**)
Keep the positioning card centered with the phone

** It is recommended to use the Protective Film. If the Magic Metal Plate needs to be removed, the film simplifies the process.



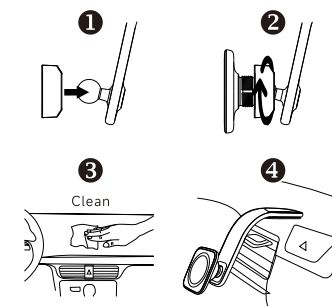
- B.** Wireless Charging Smartphones(with case)

Keep the positioning card centered with the phone



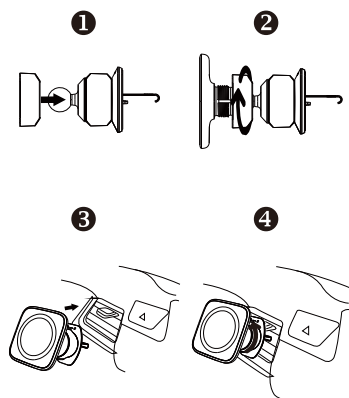
Installation instructions

Recommend use scenario: center console/dashboard /behind the control panel.

1. Please wipe the surface with the alcohol pad and keep it dry and clean before you apply the 3M tape;
2. Peel off the 3M tape and stick the Velcro base to the center console/dashboard/behind the contropanel, and wait for 2 hours;
3. Stick the Velcro on theholder to the base and bend the handle part to the angle you want.

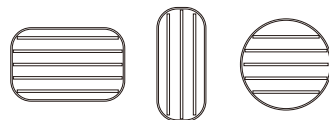


Air Vent Installation
