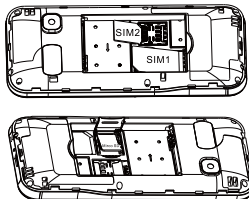
1. Before using your Plum device for the first time, charge it fully.
2. Pull out the battery cover from the back. Please insert your SIM card provided by your operator at this time. Insert the battery and close firmly the back cover.
3. Insert the USB cable connector into the unit's charging jack. Plug the charging head into AC power outlet.
4. The device indicates its charge state. When charging is finished, disconnect the USB from the device.
5. To Power ON the unit, press and hold Power key. To turn it OFF, press and hold Power key

NOTE: Always use authorized Plum accessories, any other charger can cause damage to the phone and bodily insured.

**To Insert SIM card:**

1. Firmly lift the battery cover from the back of the unit while it is faced down.
2. Insert your SIM card following the direction on the unit- Usually contacts face down.
3. Insert the external Micro SD memory for additional storage capacity.

NOTE: Please use caution when carrying, installing or taking out the SIM card, its contacts are easy to damage due to scratching or bending. Keep SIM card out of reach of children.
