## 2. Antenna requirement

The antenna is a **PCB Antenna** which permanently attached, and the best case gain of the antenna is **2.32 dBi**. It complies with the standard requirement.



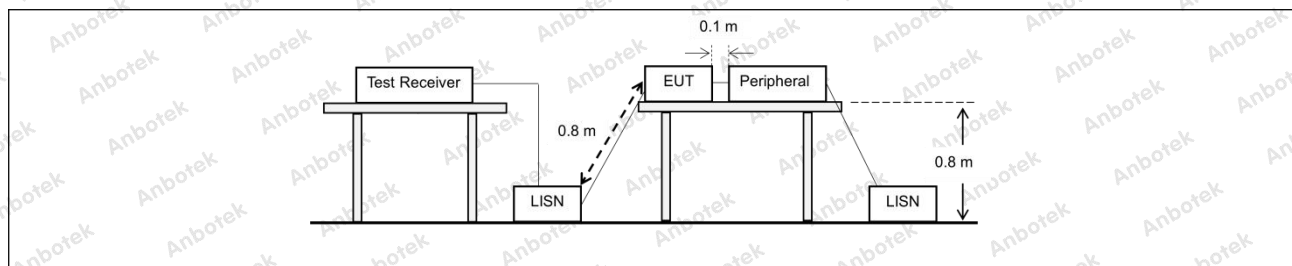
