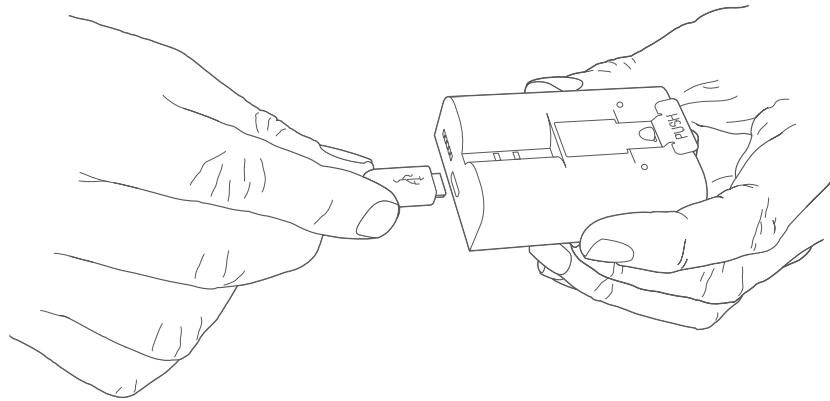
# 1. Charge and insert the battery

## Charge the provided battery.

First, fully charge the battery by plugging it into a USB port using the provided orange cable.

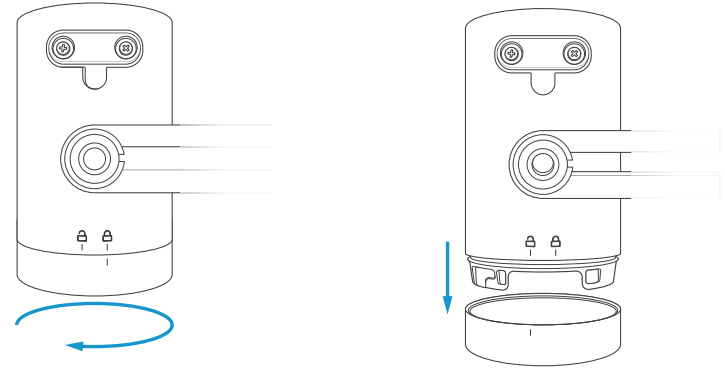
The battery is fully charged when just one LED is lit.

 = Charging  = Charged



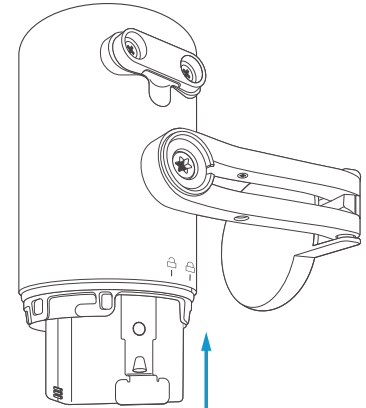
## Remove the battery cover.

Twist the battery cover counterclockwise to unlock, then remove it from your Stick Up Cam.



## Insert the battery

After charging, insert the battery into the bottom of your Stick Up Cam until it clicks into place.



## 2. Set up your Stick Up Cam Battery in the Ring app.

### Download the Ring app.

The app walks you through setting up and managing your Stick Up Cam Battery.

### Grab your Wi-Fi password.

You'll need it to set up your Stick Up Cam. Write it down below so it's handy when you need it:

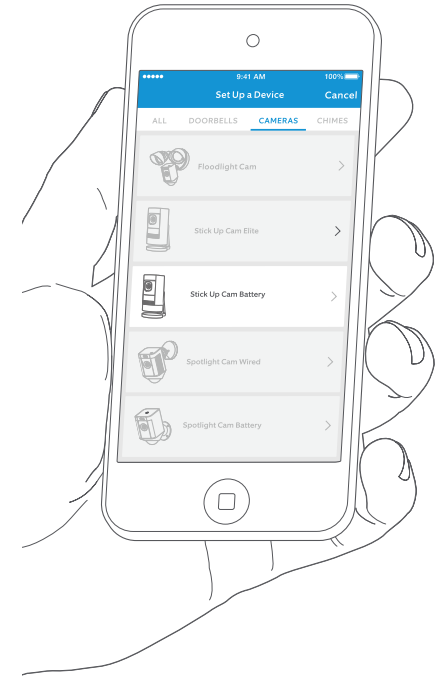
### Set up your Stick Up Cam in the Ring app.

In the Ring app, select **Set Up a Device**.

When prompted, select **Stick Up Cam Battery** and follow the in-app instructions.

### Try it out!

After setup, tap the Live View button in the Ring app to see live video from your Stick Up Cam.



### Blue light flashing?

If the light on the front of your Stick Up Cam Battery flashes after setup, it may be powering up or updating its software.

When the flashing stops, Stick Up Cam is ready to use.

### 3. Install your Stick Up Cam Battery.

#### Choose a location.

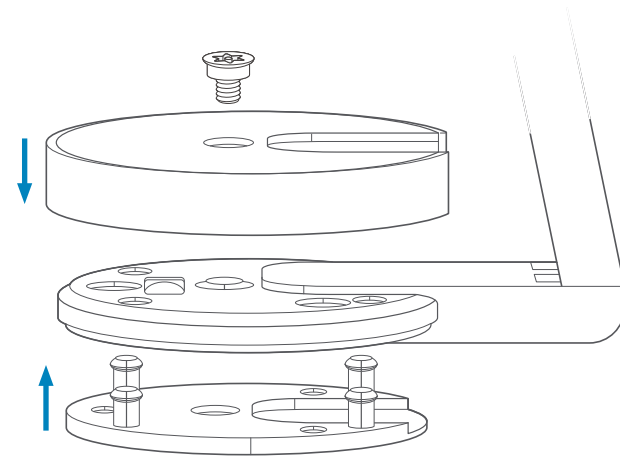
Stick Up Cam is happy just about anywhere, indoors or out. It can sit on its own stand, or mount to a wall or ceiling.

Simply pick any spot where it can provide the view you want.

#### Installing on a shelf or table?

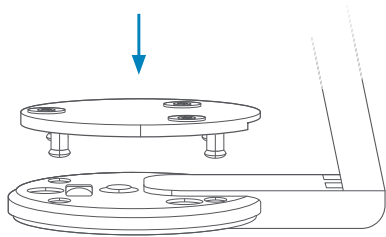
Simply snap the cover on the top of the base, and push the rubber pad into the bottom of the base. Then insert and tighten the security screw.

That's it! You can skip to the next section.

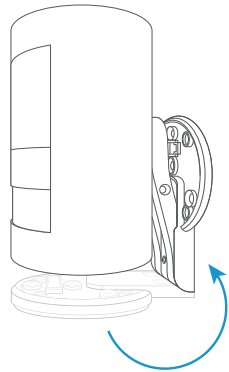


## Mounting on a wall?

Push the rubber pad into the top of the base.



Flip the base toward the rear.

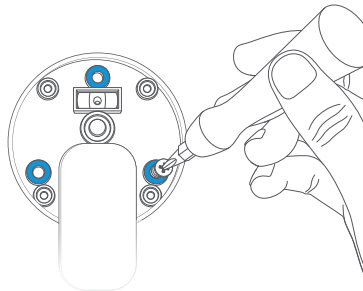


### Drive the screws.

Hold the circular part of the base against your wall, rubber-side down. Use the integrated level to ensure it's straight.

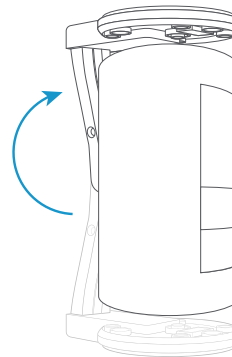
Then, mount it with the included screws.

Finally, snap the cover onto the base and install the security screw.

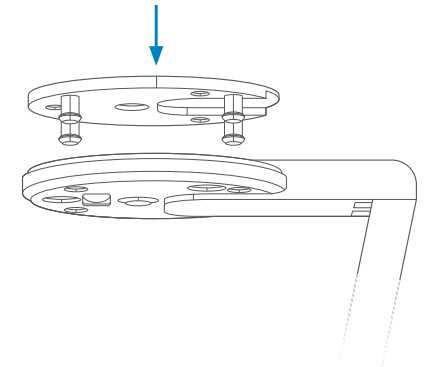


## Mounting on a ceiling?

Swivel the base above the camera.



Push the rubber pad into the bottom of the base.

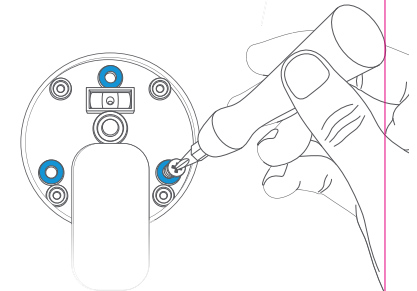


### Drive the screws.

Hold the circular part of the base against your ceiling, rubber-side down.

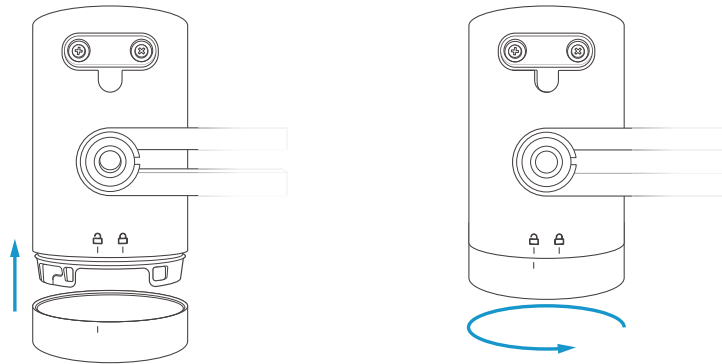
Then, mount it with the included screws.

Finally, snap the cover onto the base and install the security screw.



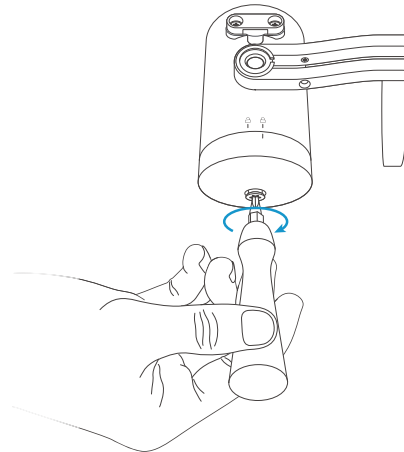
## Attach the battery cover.

Line up the “open lock” symbol on the rear of your Stick Up Cam with the line on the battery cover. Then push the cover on and twist clockwise to lock it in place.



## Tighten the screw.

Use the star-shaped end of your Ring screwdriver to tighten the screw on the bottom of your Stick Up Cam.



# 4. Need a little setup help?

If your in-app setup doesn't go as planned, try these tips:

## Get your Wi-Fi password just right.

The most common setup issues come from entering the wrong Wi-Fi password. These passwords are case-sensitive, and every little error counts.

## Reboot your router.

If you entered the right password but you're having no luck, try turning your Wi-Fi router off, wait 30 seconds, then turn it back on.

Then, begin setup again in the Ring app.
