2. Antenna requirement

The antenna is a ceramic antenna which permanently attached, and the best case gain of the antenna is -0.58 dBi . It complies with the standard requirement.



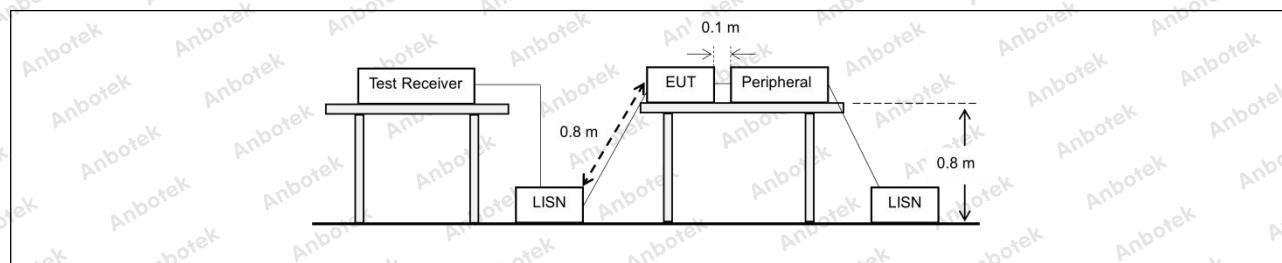
