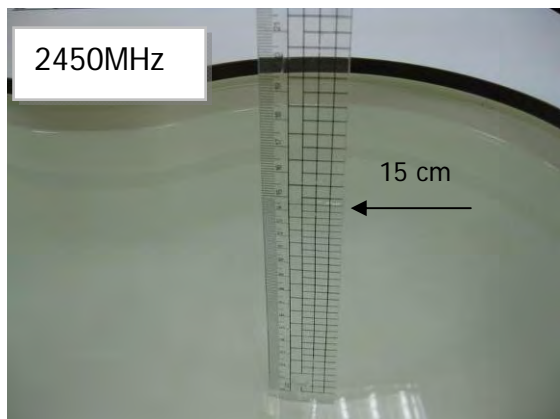

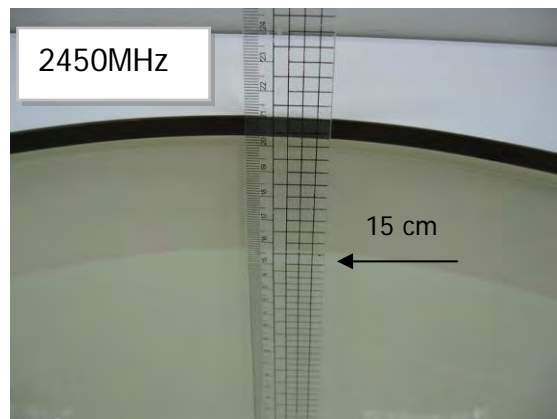

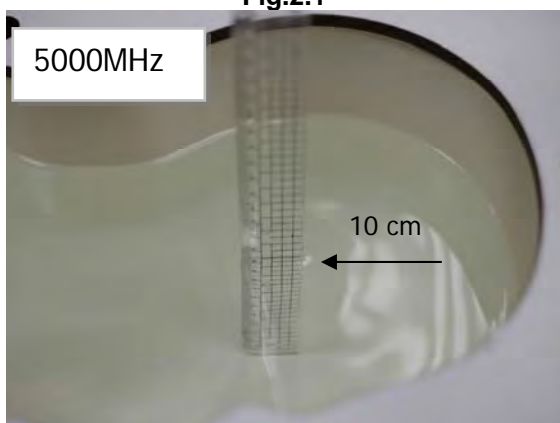

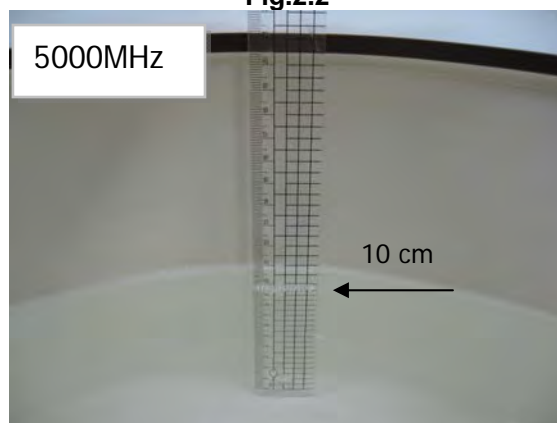

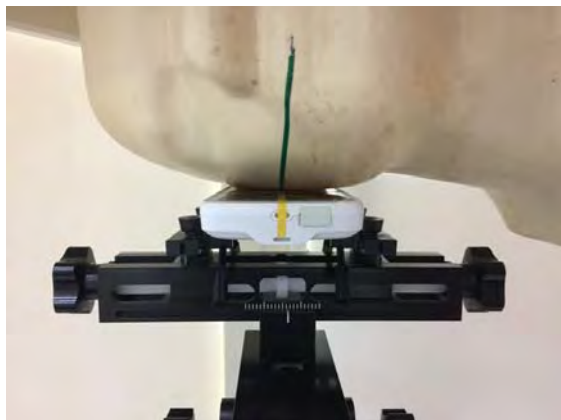


Fig.3 Right Head Section / Cheek-Touch Position

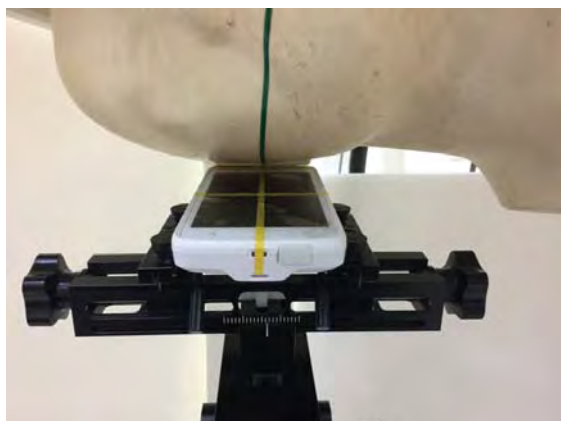
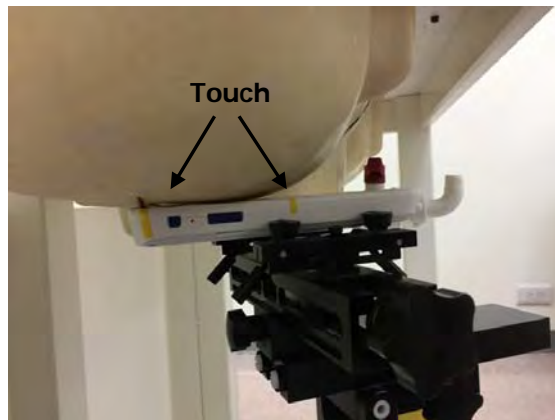
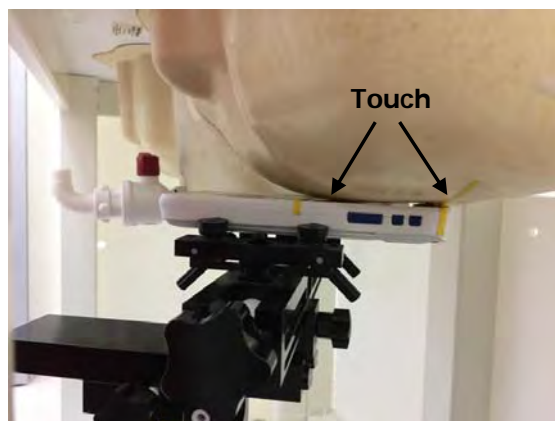


Fig.4 Right Head Section / Ear-Tilt Position(15°)

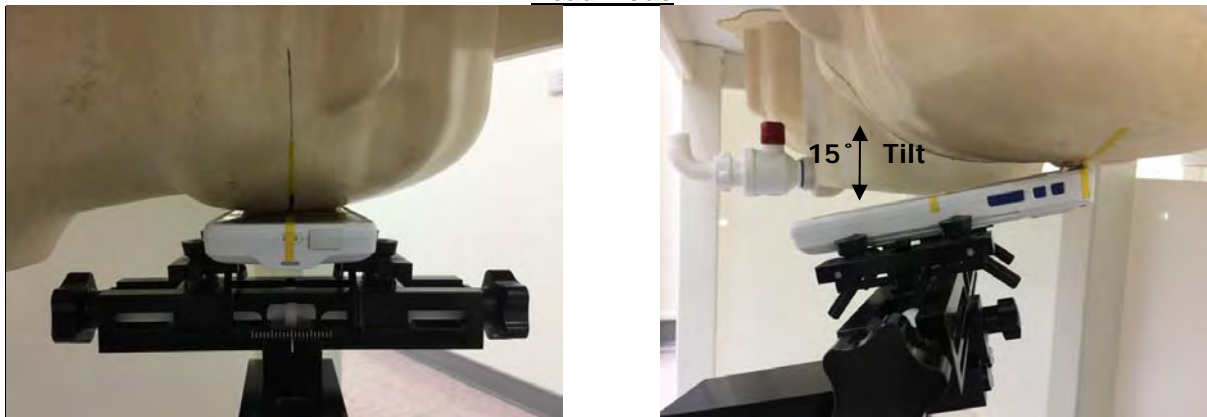


Fig.6 Left Head Section / Ear-Tilt Position(15°)

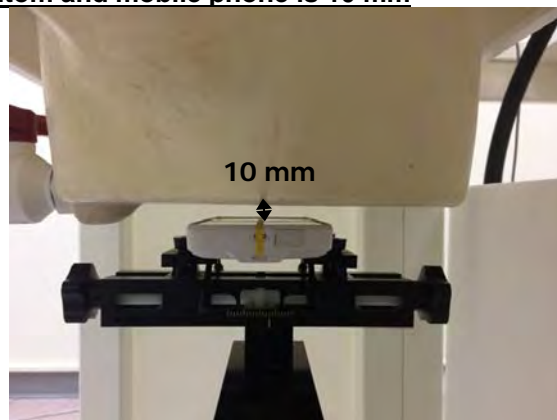

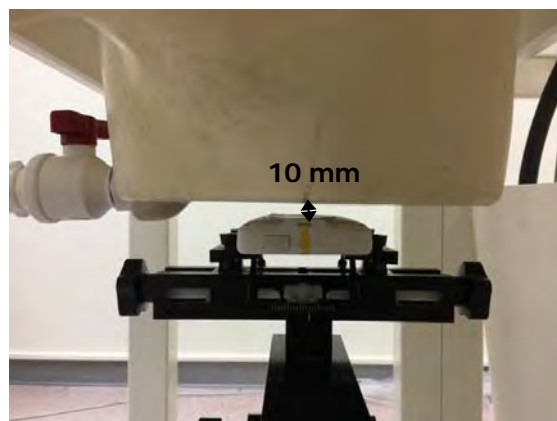

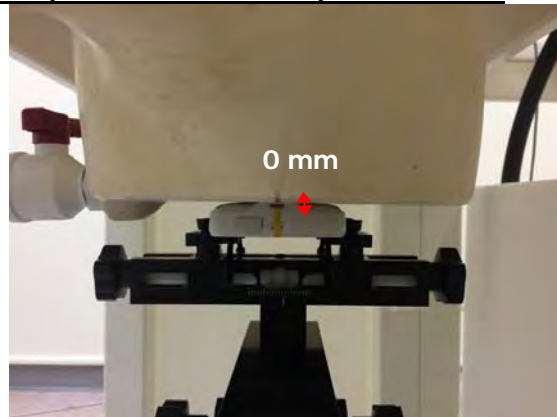

**Product specific 10-g SAR - distance between flat phantom and mobile phone is 0 mm**



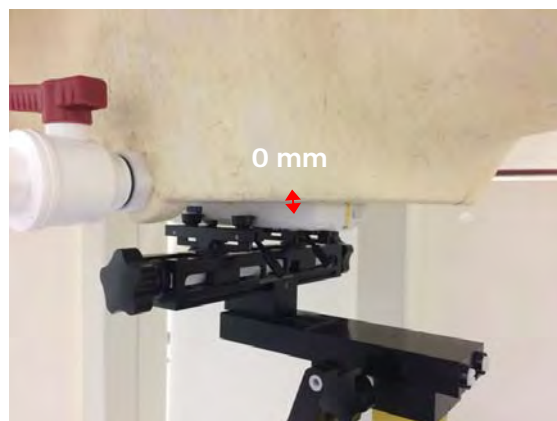
**Fig.9 EUT Back side to flat phantom**

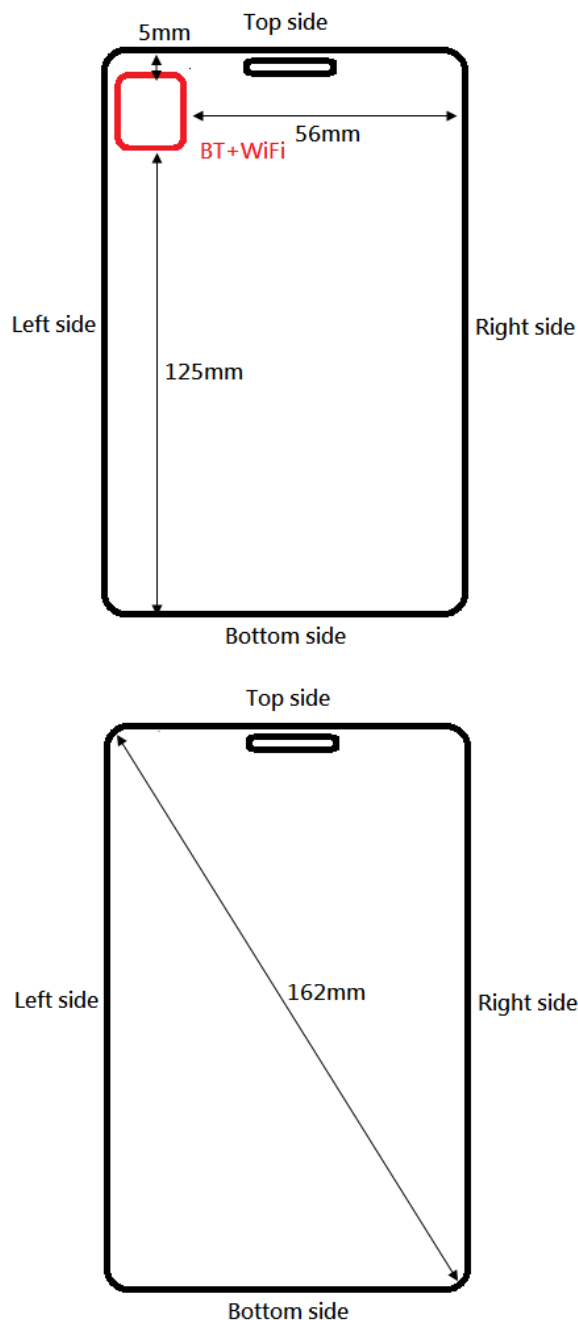


Fig.15 Antenna location and dimensional size
