1 RF EXPOSURE

1.1 Standard Applicable:

According to §1.1307(b)(1), systems operating under the provisions of this section shall be operated in a manner that ensure that the public is not exposed to radio frequency energy level in excess of the Commission's guideline.

This is a Portable device with its physical nature to be used nearby, the distance between radiating structure and human is less than 20cm.

As per KDB 447498 D01 4.3.1, The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$$\left[\frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \right] \cdot \sqrt{f(\text{GHz})} \leq 3.0 \text{ for 1-g Head \& Body SAR and } \leq 7.5 \text{ for 10-g extremity Hand SAR, where}$$

*f (GHz) is the RF channel transmit frequency in GHz
Power and distance are rounded to the nearest mW and mm before calculation*

1.2 Measurement Result:

Step 1:

This is a portable device and the max. output power including tune-up tolerance is 0.839 (mW), lower than the threshold given and derived as formula given above, where

$$=0.839(\text{mW})/5(\text{mm}) \cdot \sqrt{4 \text{ (GHz)}} = 0.336 < 3.0$$
