6. Safely collect the used batteries.

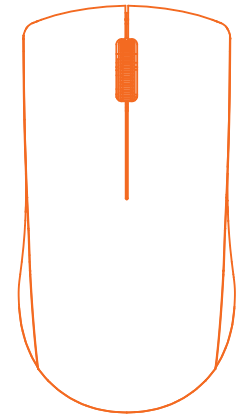
