
Jack Bluetooth Speaker and Wireless Charging Pad

Instructions:

(Be sure to fully charge the speaker before using for the first time).

- 1. Charging the Speaker
- Connect the provided charging cable to a power source and to the micro USB port on the speaker (3).

The LED indicator light will glow red when charging and turn off when fully charged.

- 2. Bluetooth® Setup:
- Turn ON/OFF switch to the ON position, LED Indictor will flash BLUE.
- Turn on the Bluetooth function on mobile device, Select "Jack BT" pairing name.
 LED will glow BLUE if successfully paired
- * Speaker will automatically pair if the mobile device has been paired before.
- Press and hold ON/OFF button to turn off the device
- 3. Wireless Charging:
- Connect the provided charging cable to a power source, place wireless charging supported mobile device on top charging pad.
- Device will begin to charge automatically

SAFETY PRECAUTIONS:

- WARNING-When using this product, basic precautions should always be followed:
- 1. Read all the instructions before use.
- Never store or use this product in temperatures below 32°F(0°C) or above 115°F(45°C).
- Do not overcharge Phone. Unit may get hot with excessive use. Remove Phone when it is fully charged. Never charge for more than 7 hours at a time.
