OUTLINE

1. How to use FOB-4F81M44

- FOB-4F81M44 is a part of Remote Keyless System.
- This unit controls door lock/door unlock/tail gate open/panic/trunk open/remote engine start-stop/forward/backward wirelessly.

2. Introduction of Transmitter (FOB-4F81M44)

- These units use the battery
- Frequency is 433.92MHz

GENERAL DESCRIPTION

PRIMARY FUNCTION

- Remote door lock/unlock/tail gate/panic
- Operating voltage: 3V DC
- Center freq.: 433.92MHz

MANUAL

1. LOCK Button

If the LOCK button is pressed, then TRANSMITTER sends the LOCK data.

2. UNLOCK Button

If the UNLOCK button is pressed, then TRANSMITTER sends the UNLOCK data.

3. Tail gate Button

If the Tail gate button is pressed, then TRANSMITTER sends Tail gate open data.

4. HOLD Button

If the HOLD button is pressed, then TRANSMITTER sends the HOLD data.

5. FORWARD Button

If the FORWARD button is pressed, then TRANSMITTER sends the FORWARD data.

6. BACKWARD Button

If the BACKWARD button is pressed, then TRANSMITTER sends BACKWARD data.
