RSS-102 § 2.5.2 Exemption Limits for Routine Evaluation - RF Exposure Evaluation.

RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

• at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1.31 x $10^{-2} f^{0.6834}$ W (adjusted for tune-up tolerance), where *f* is in MHz;
