

Charging Your Speaker



1. Insert the included USB charging cable's USB head into the DC 5V USB port on the back of the speaker.



2. Insert the USB charging cable's standard USB head into the USB port of a computer or suitable USB charging adapter.


This product does not contain battery, must be connected to the power supply when using.

Audio Modes

Bluetooth:

Push the power switch to the On position to turn it On.

On your phone, go into the Bluetooth page in the settings app. Make sure that Bluetooth is turned On. Connect to the available device "Glitter Lamp".





Auxiliary Port:

Using the included auxiliary cable, insert one end into the speaker's Auxiliary jack and the other end into your phone or another audio source.




TWS Pairing

TWS pairs two speakers to play audio together.

Turn On two speakers at the same time. A sound will ring from the speakers once connected. Then re-connect speakers to Bluetooth.

Note: TWS pairing only works with two of the same speakers.

Speaker Controls



- 1. Press the Volume button to go back to the previous track. Press and hold to decrease the volume.
- Press and hold the Play/Pause button to play and pause music. Press to change light mode. answer/ hang up the phone by long pressing.
- 3. Press the Volume + button to go to the next track. Press and hold to increase the speaker's volume.
