Getting Started

Download app

Use your phone to scan the **App QR CODE** printed on the front of the FlashLink BLE In-Transit Logger. Both IOS® and Android® versions are available.

Register

Contact DeltaTrak to register your user name and password for on-line data management. You also can use Guest to login to manage the device and data (see Figure 1).

Connect BLE device

In the My Device Screen click on Add a Device. There are 3 methods to find and connect to the BLE logger (see Figure 2):

- A. Scanning the BLE logger code
- B. Bluetooth scanning the BLE loggers
- C. Manually entering trip number

Data Retrieval

Click the device in the list, and the app will connect and read the default configuration of the logger automatically (see Figures 3 and 4). Click DATA menu, the App will read the data from the device automatically (Figure 5). The temperature charts and data tables will be displayed and saved in the App.

Operation

Start the logger

Press the  button for 5 seconds till both LED's light up. The ACTIVE LED will then flash every 5 seconds indicating the logger is working.

Generating the PDF report

A PDF trip report can be created by using the App (see Figures 6 and 7). PDF reports created by the app will **not** stop the logger, allowing for continued monitoring until the end of the trip duration.

- A. Click "PDF Report"
- B. After the report creation click "Share"
- C. Chose your preferred mobile app to share the PDF report



Stopping the logger

Connecting the logger into any computer USB port will automatically stop the logger and generate the PDF trip report for viewing.


