


Test Graphs of Occupied Bandwidth






























Test Graphs of DTS Bandwidth


















Test Graph 802.11n20 ANT1 2437 MCS0 DTSBW

















Test_Graph_802.11g_ANT1_2412_6Mbps_Higher Band Emissions

































































Test Graphs of Band Edge Emissions in Non-Restricted Frequency Bands

- (2). Set the EUT Work on the top, the middle and the bottom operation frequency individually.
- (3). Set SPA Trace 1 Max hold, then View.




Test Graphs of Conducted Output Power Spectral Density
