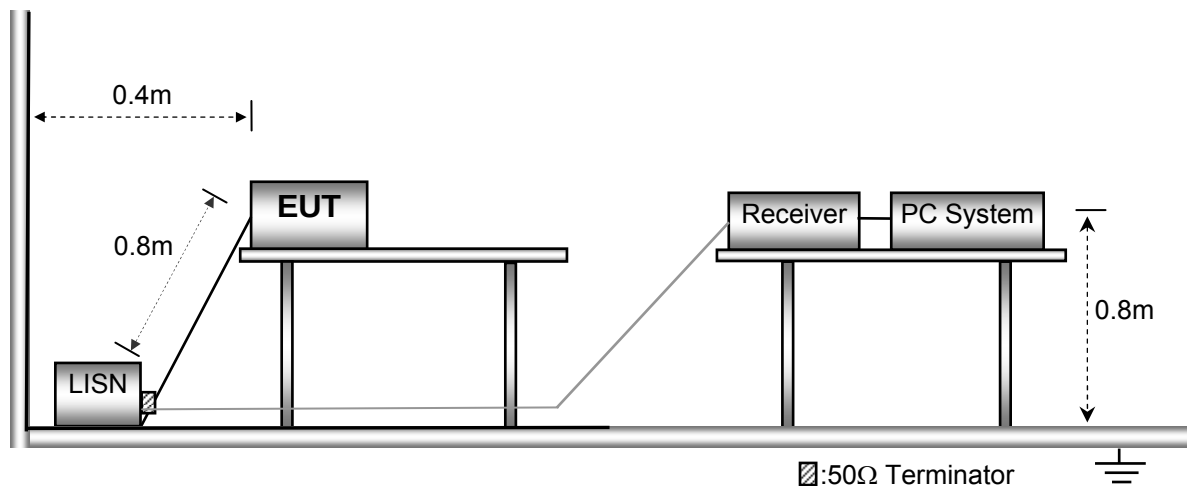

The AC Power Line Conducted Emissions tests were performed in accordance with the ANSI C63.4 .

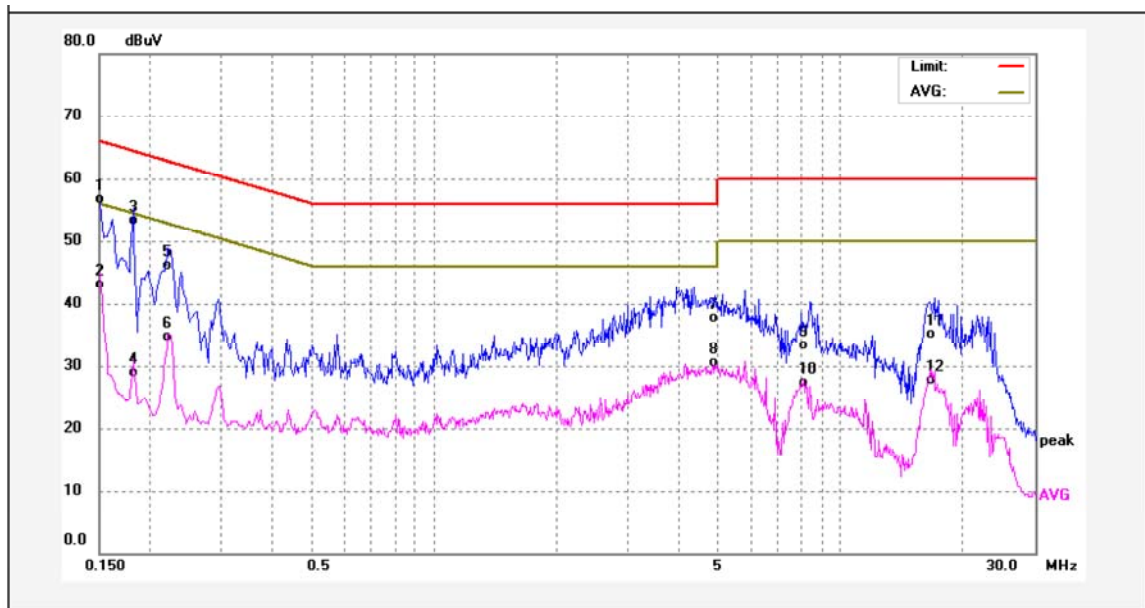


6.1.3 Measurement Data

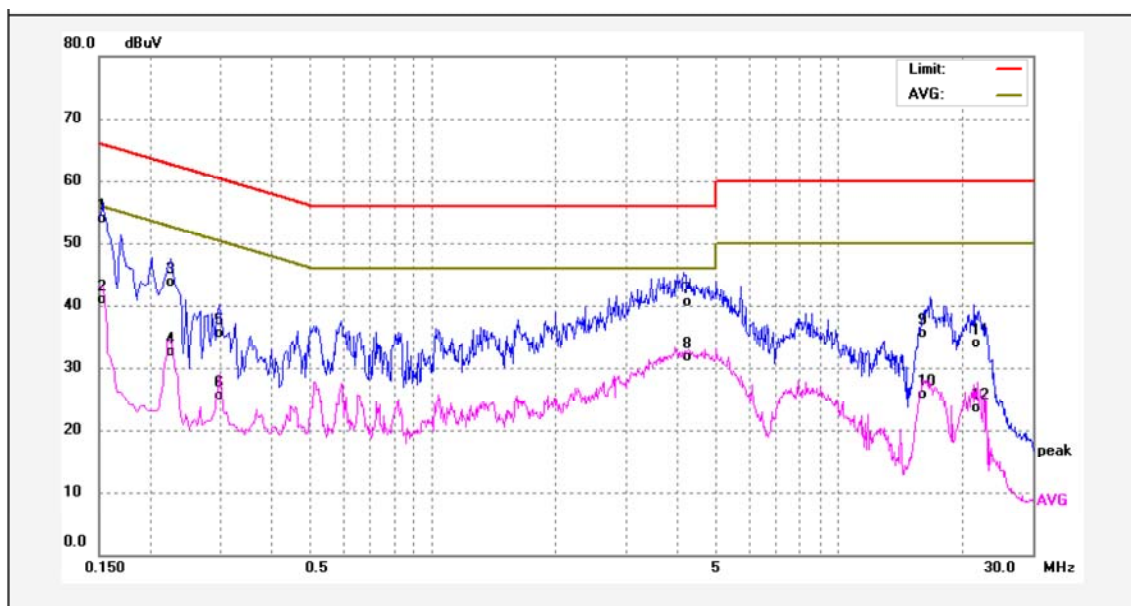

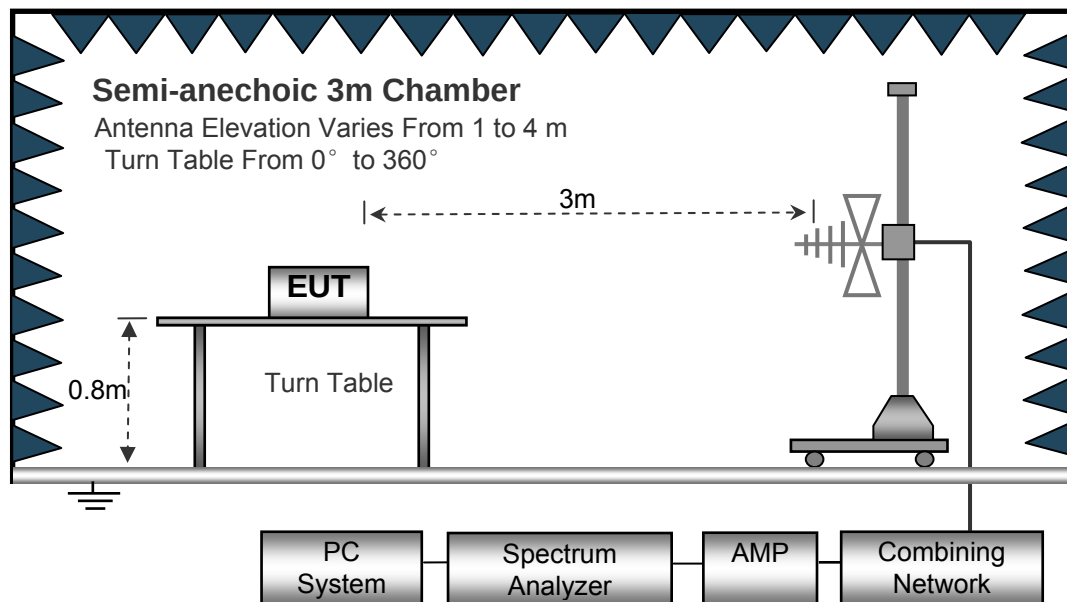

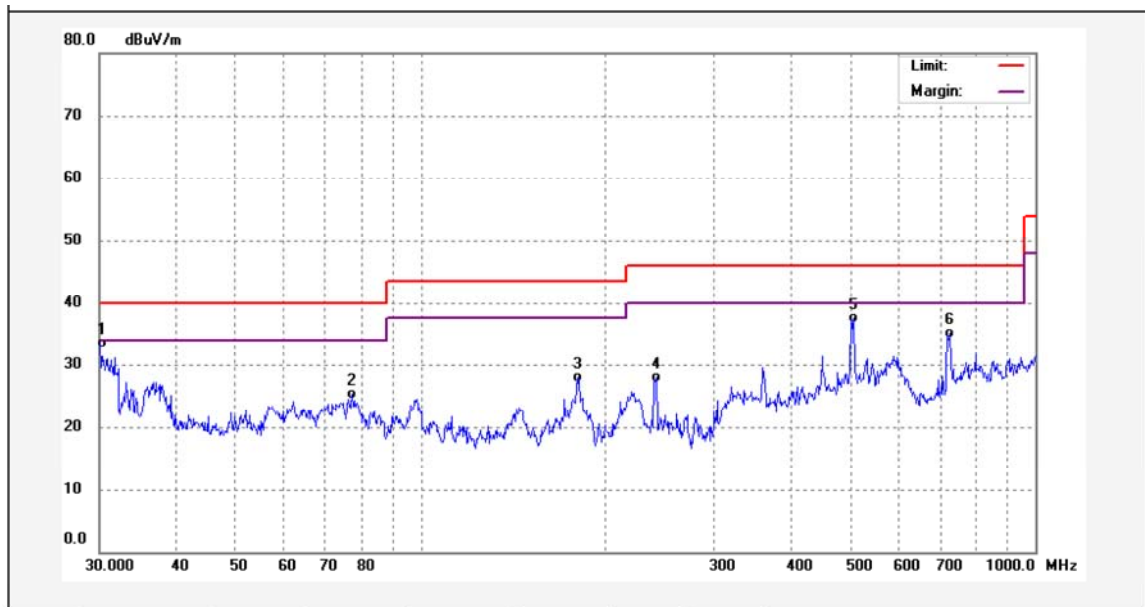

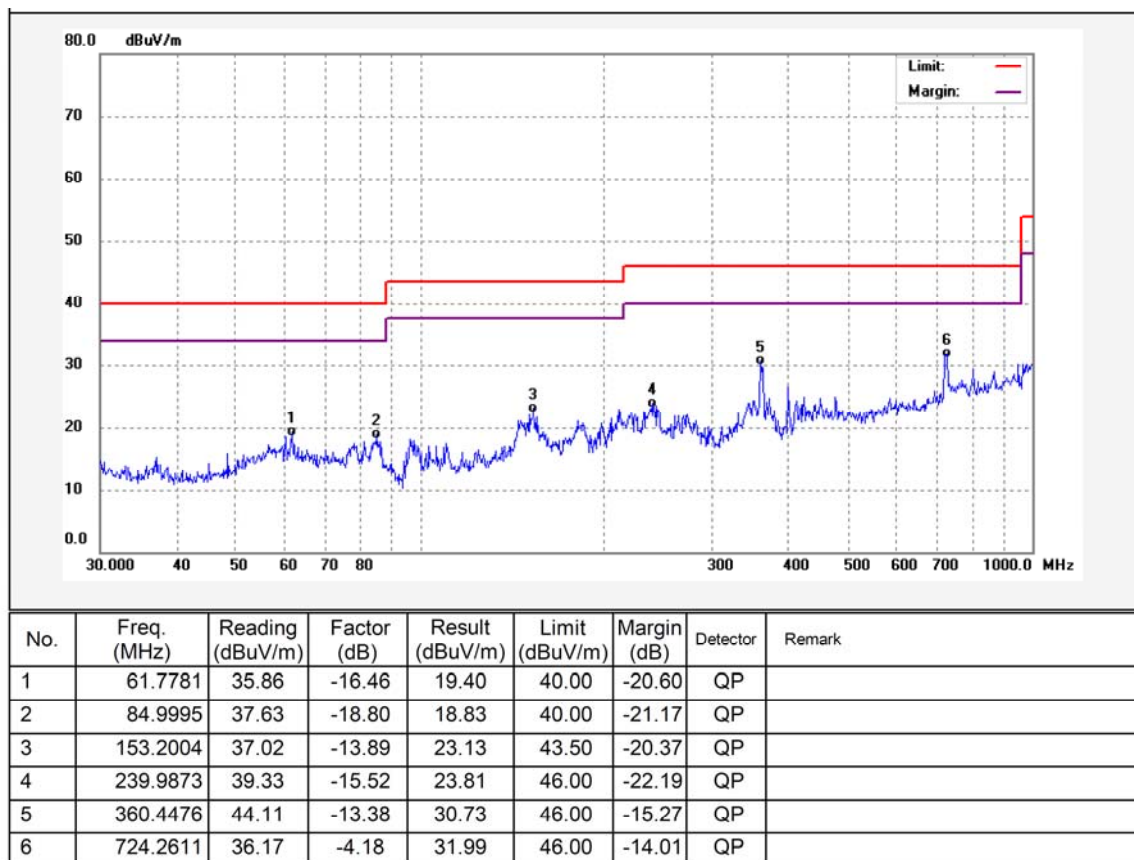

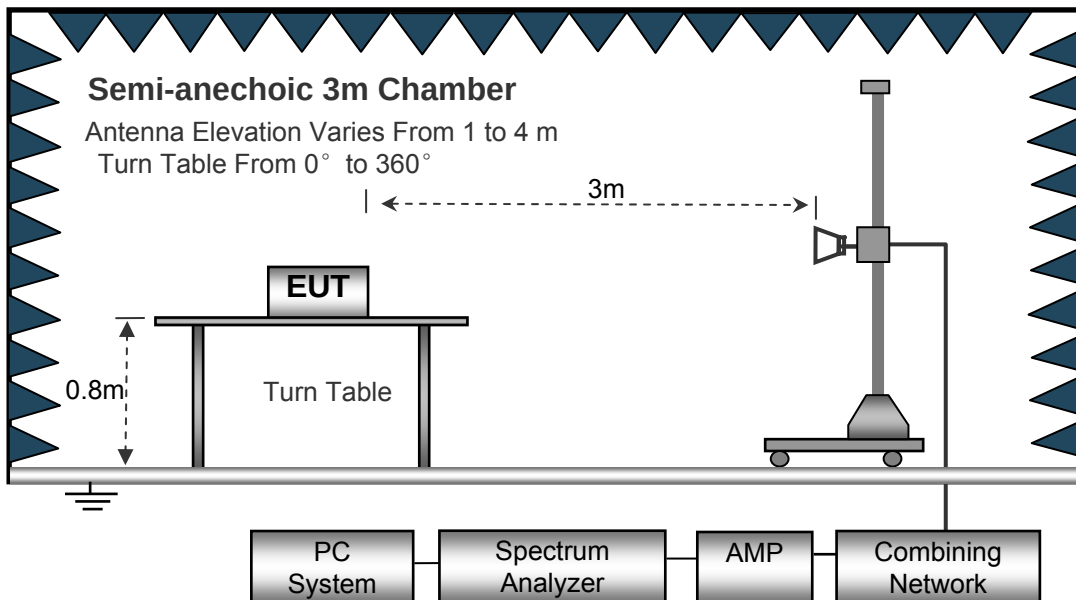

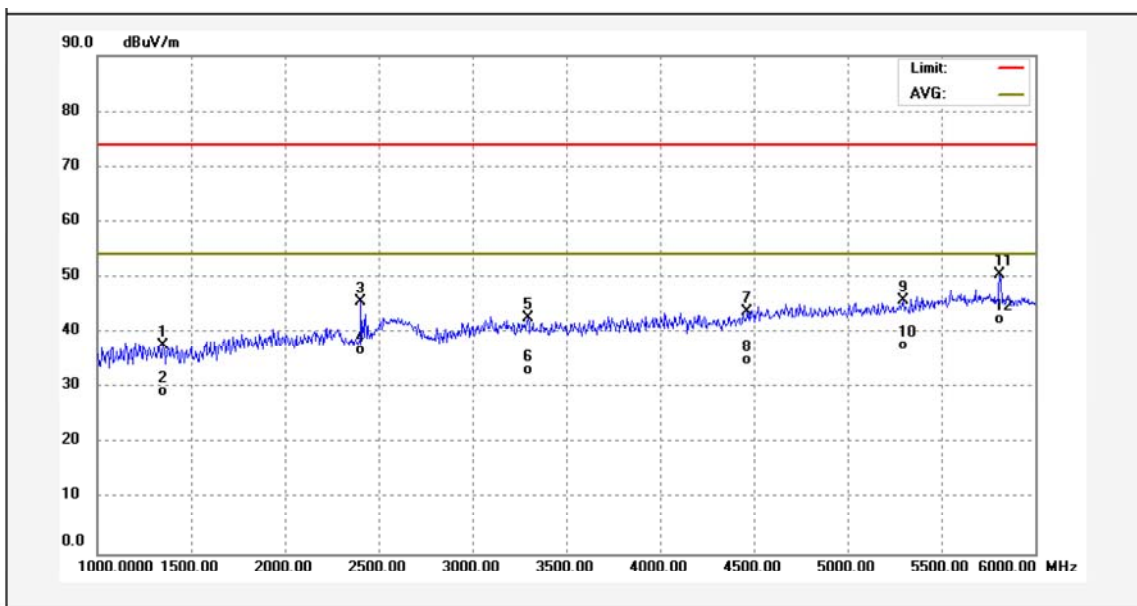

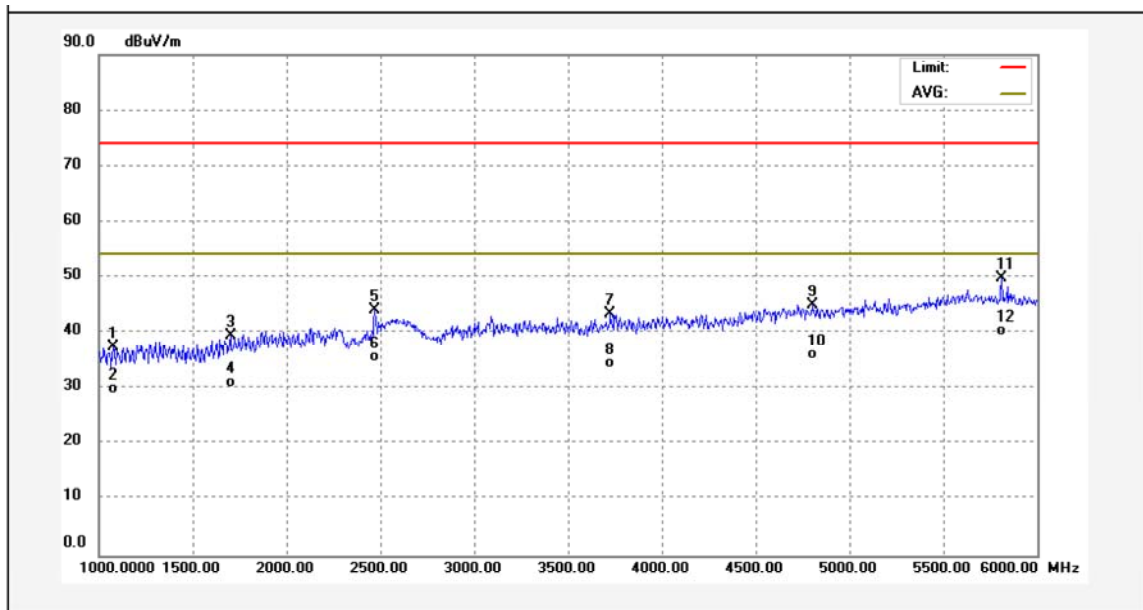

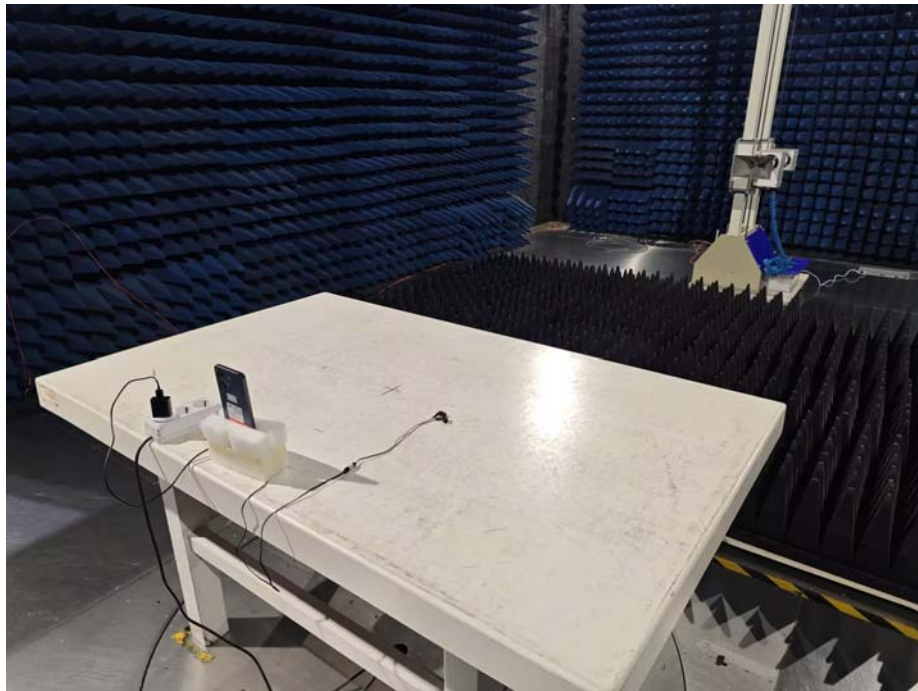
