## 2. EVALUATION METHOD

According to 447498 D01 General RF Exposure Guidance v05 The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq$  50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)]  $\cdot [\sqrt{f}(GHz)] \le 3.0$  for 1-g SAR and  $\le 7.5$  for 10-g extremity SAR.

Where f(GHz) is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation

## 3. CALCULATION

BT(BLE):

P<sub>t</sub>=-4.913dBm=0.32mW

The value of the Maximum output power Pt is referred to the test report of the CFR47

§15.247.

The result for RF exposure evaluation SAR=(0.32mW /5mm) .[ $\sqrt{2.44(GHz)}$ ]= 0.099<3.0 for 1-g SAR and  $\leq$  7.5 for 10-g extremity SAR.

2.4G GFSK:

P<sub>t</sub>=1.495dBm=1.41mW

The value of the Maximum output power Pt is referred to the test report of the CFR47

§15.247.

The result for RF exposure evaluation SAR=(1.41mW /5mm) .[ $\sqrt{2.401(GHz)}$ ]= 0.437<3.0 for 1-g SAR and  $\leq$  7.5 for 10-g extremity SAR.

Note: BLE and 2.4G GFSK don't work at the same time.
