Worse case is as below: [2480 MHz, 4.08 dBm, (2.56 mW) output power] (2.56/5) $\cdot [\sqrt{2.480}(GHz)] = 0.81 < 3.0$ for 1-g SAR Then SAR evaluation is not required.
