USER GUIDE

DOWNLOAD IT

If you haven't already, get the free SleepIQ® app from Google Play or the iTunes Store®.



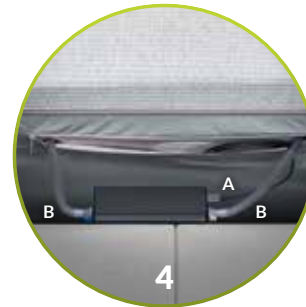
UNPACK IT

The it™ bed requires a solid, flat surface. If you're using a bed frame and base, set them up before unboxing the mattress.



UNROLL IT

Set the mattress on your base and remove it from the bag. Let it unroll (it will inflate on its own in about 15 minutes). Once inflated, ensure the green it™ bed label is at the foot of the bed.



UNZIP IT

With the mattress fully inflated, unzip the pocket at the foot of the bed. Pull the cord (A) out of the pocket and plug it into the ActiveComfort™ technology (ACT) module. Connect the two color-coded air hoses (B) from the pocket to each side of the ACT module. Tuck the module into the pocket and zip it closed.

POWER IT

Pull out the power cord from the opening at the head of the bed, plug it into the power supply module and place the module on the floor. Plug the power cord into the power supply module and into a wall outlet. Two lights on the power supply module will blink. Mattress setup is complete.

CONNECT IT

Open your SleepIQ® app on your smart device and follow the instructions to connect your system. All five icons on the power supply module will light up. Now you're ready to sleep on your new it™ bed.
