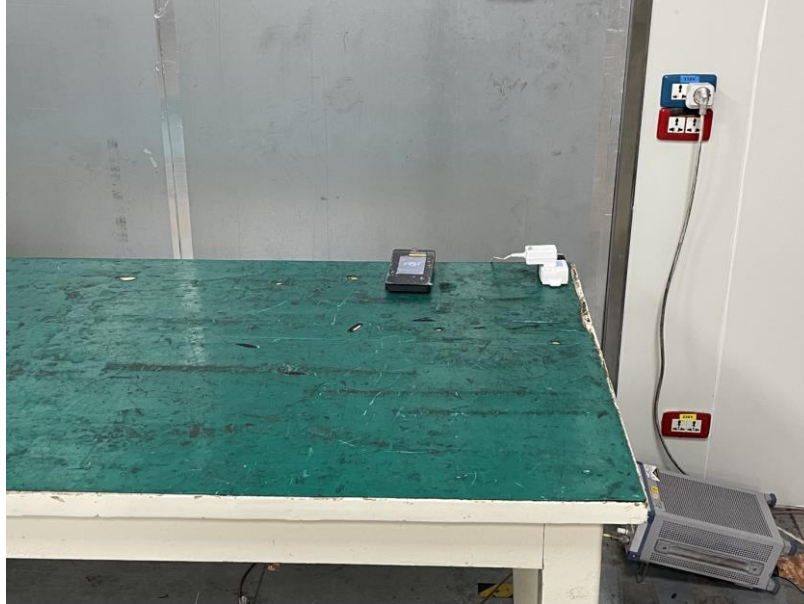

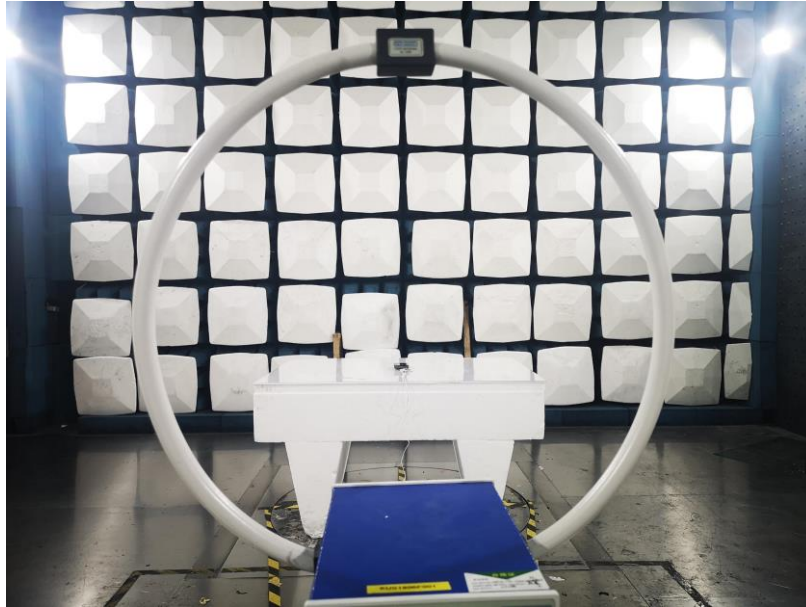

30MHz to 1GHz



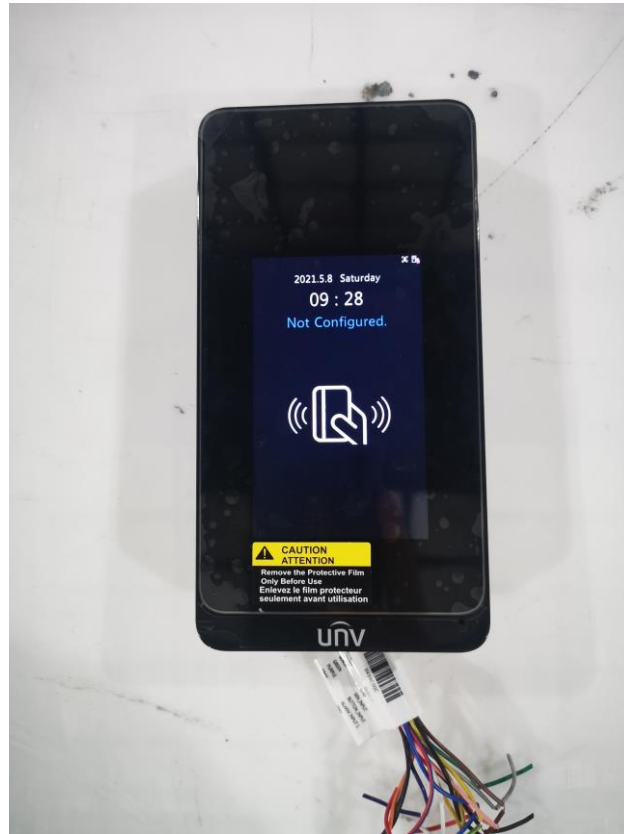
