#### **Product Description for Equipment under Test (EUT)**

The *Hyundai Corporation* 's product, model number: E245S (FCC ID: RQQHLT-E24FSL) or the "EUT" in this report was a *Mobile Phone*, which was measured approximately:  $11.2 \text{ cm } (L) \times 4.6 \text{ cm } (W) \times 1.3 \text{ cm } (H)$ , rated with input voltage: DC 3.7 V rechargeable Li-ion battery or DC 5.0 V from adapter. The highest operating frequency is 611 MHz.







#### **Test Procedure**

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.
