Please find below the responses to your questions regarding the ASoP for this filing.

*Yes – confirmed using Google Maps (it is an apartment, refer to attached screen shot of the address from Google Maps).*

2. Is the agent physically located at that valid US address such that the agent can be legally served at that address?

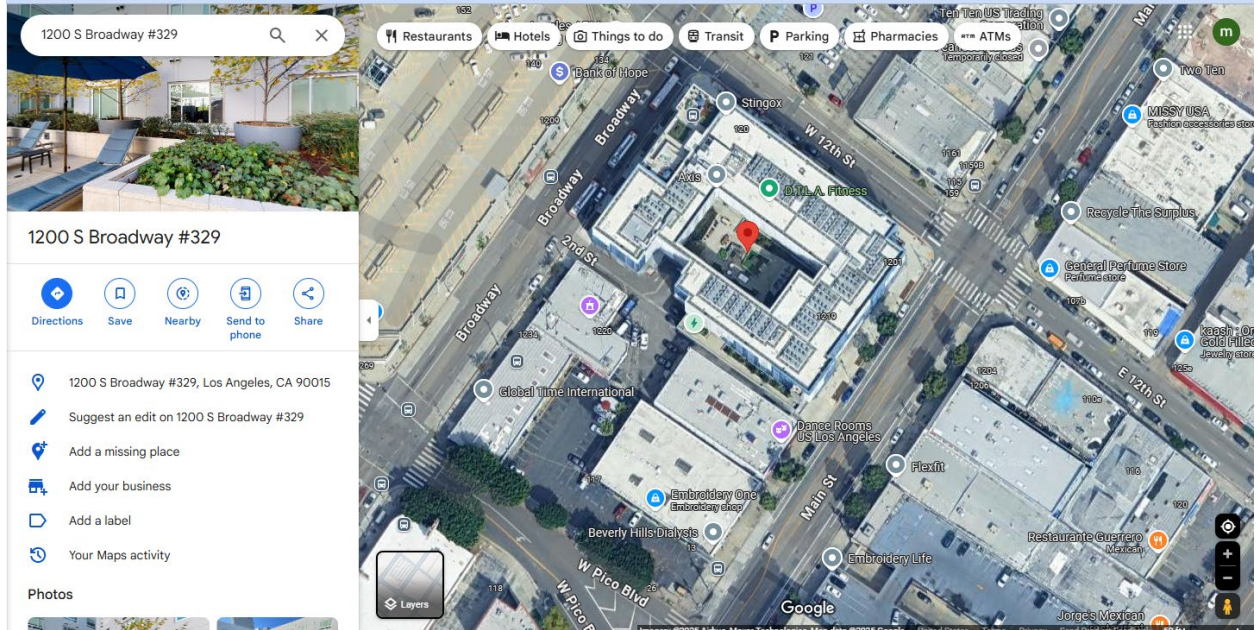
*Yes – the TCB confirmed that the agent is physically at the address via email (as part of the checks for a different grantee using the same agent) using the email address detailed in the letter from the agent agreeing to act as the agent. The email verification is attached.*

*Yes – this was clearly documented in the attestation uploaded to the F-731 as an attestation exhibit (description “agent letter”). Letter also attached. The letter is signed by both grantee and agent, agent acceptance signature is in the second part of the document.*

Additional verification was requested during the TCB review of the application and in response the ASoP provided the Articles of Organization which is attached to this response.

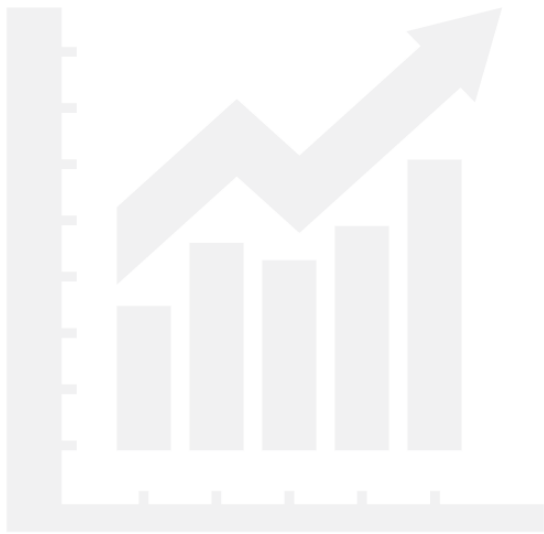
