

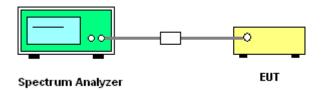



6 dB Bandwidth Plot on Channel 00





3.2 Output Power Measurement

3.2.1 Limit of Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

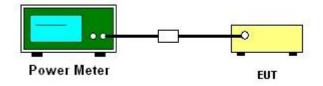

- 5. Detector = peak, Sweep time = auto couple, Trace mode = max hold, Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level.
- 6. Measure and record the results in the test report.
- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.





PSD 100kHz Plot on Channel 19








PSD 3kHz Plot on Channel 00

PSD 3kHz Plot on Channel 19





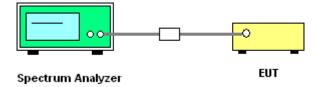

Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.
- 5. Measure and record the results in the test report.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.




Low Band Edge Plot on Channel 00




Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 00

Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 00







3.5 Radiated Band Edges and Spurious Emission Measurement

3.5.3 Test Procedures

- 1. The testing follows ANSI C63.10-2013 clause 11.11 & 11.12
- 2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.






For radiated emissions below 30MHz



3.7 Antenna Requirements

3.7.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. 




