The EUT was setup according to EIA/TIA 603D

In order to measure the carrier frequency under the condition of AFC lock, it is necessary to make measurements with the EUT in a "call mode". This is accomplished with the use of DOC COMMUNITY. DIGITAL RADIO COMMUNICATION TESTER.

- Measure the carrier frequency at room temperature.
- Subject the EUT to overnight soak at -30°C.
- With the EUT, powered via nominal voltage, connected to the CMW500 and in a simulated call on middle channel for LTE band 12, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 4. Repeat the above measurements at 10°C increments from -30°C to +50°C. Allow at least 1.5°C. hours at each temperature, unpowered, before making measurements.
- Re-measure carrier frequency at room temperature with nominal voltage. Vary supply voltage from minimum voltage to maximum voltage, in 0.1Volt increments re-measuring carrier frequency at each voltage. Pause at nominal voltage for 1.5 hours unpowered, to allow any selfheating to stabilize, before continuing.
- Subject the EUT to overnight soak at +50°C.
- With the EUT, powered via nominal voltage, connected to the CMW500 and in a simulated call on the centre channel, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- Repeat the above measurements at 10 °C increments from +50 °C to -30 °C. Allow at least 1.5 hours at each temperature, unpowered, before making measurements
- At all temperature levels hold the temperature to +/- 0.5°C during the measurement procedure.

Frequency Stability under Voltage Variations:

Set chamber temperature to 20°C. Use a variable AC power supply / DC power source to power the EUT and set the voltage to rated voltage. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and recorded the frequency.

Reduce the input voltage to specify extreme voltage variation (±15%) and endpoint, record the maximum frequency change.
