I have just received email notification from Andy Leimer that " The fees have not cleared" for the submission outlined above.

The cheque was sent by courier consignment and arrived on 4 May 2001. It was signed for by C. Palmieri. The cheque was drawn on the HSBC bank, cheque number J344221.

Please find the details of the consignment following this page (page 3).

Is this a case of a lost cheque or was the cheque dishonoured? The statement from Andy Leimer was too vague to ascertain the actual problem.

Please contact me if the problem is a dishonoured cheque and I will trace the problem from here. I have already asked the bank to check if this cheque has been presented.

There is one last possibility I can think of and that refers to a letter I attached to the cheque. When I submitted the 731 form and generated the 159 form, the total fees to be paid was listed as \$495. In my letter I stated that I assumed this was an error as the amount should have been \$640. I have included a copy of this letter for your perusal (page 2). I sent a cheque for \$640, stating that if that amount was incorrect that I should be contacted.
