



How to solve abnormal wireless charging issues?</b> The charger will detect and turn off the power automatically when metal foreign objects in the charging area; The product will resume charge when removing the object.</p> <p><b>2. Why does the wireless charger gets hot while charging?</b> Energy losses of electromagnetic conversion exist during charging, a part of them will transfer to heat. It is a normal phenomenon.</p> <p><b>3. What should be noted while charging?</b> Please disconnect power supply in time after fully charged the device to avoid continuous heating.</p>	<p><b>Notice</b></p> <ul style="list-style-type: none"> <li>This product is suitable for iPhones with both wireless charger and magnetic suction functions.
