> Question #1: In the request for modular approval letter, it mentioned
this
> device will be used as mobile device per section 2.1091 of FCC rules.
In
> the page 22 of user manual, in the caution statement, it requires to
have
> this device and its antenna to be installed to provide 20 cm separation
> distance but manual also indicate this device complies with section
> 2.1093(d)(2) (portable device) of RF exposure compliance. In the
> operational description and user manual, mentioned this CF card is
suitable
> for handheld device like PDA or tablet PC.
>
> The intended usage of this CF card with external antennas are designed
to be
> used in both Portable/ section 2.1093 and Mobile / section 2.1091 of FCC
> rules. The antenna cable length of two proposed antennas are less than
20
> cm. If this device is used for handheld product or laptop/tablet
device,
> the 20 cm separation distance can not be maintained. If this device is
used
> by access point or wireless router, due the design of access point and

- > router, 20 cm separation distance can be maintained.

- > Based upon above assessment, please confirm the following :
- >
- > a. This application will be reviewed as limited modular approval to be used
 - > in access point, wireless router or desktop computer where the 20 cm
 - > separation distance can be maintained between transmitting antenna to the
 - > body of end user. Use in handheld device or notebook computer are
 - > prohibited. This device can only be installed by OEM installer, user
 - > installation is prohibited.
 - >
 - > B. if this device is going to be sold to handheld device or notebook
 - > computer, the antenna needs to be installed inside typical PDA or notebook
 - > computer to be tested for radiated spurious emission and restricted band
 - > edge. The minimum separation distance between the transmitting antennas to
 - > the body of end user will be at least 2.5 cm separation distance. Due to
 - > the output power is below $120/2.4\text{GHz}=50\text{mW}$, with at least 2.5 cm separation
 - > distance, SAR evaluation is not required.

 - > C. if this device is going to be used as mobile device per section 2.1093 of
 - > rules, please delete the statement in page 22 of user manual where
 - > indicating that this device complies with 2.1091(d)(2) of RF exposure
 - > compliance. In addition, please remove all device usages for handheld
 - > device or notebook computer.
