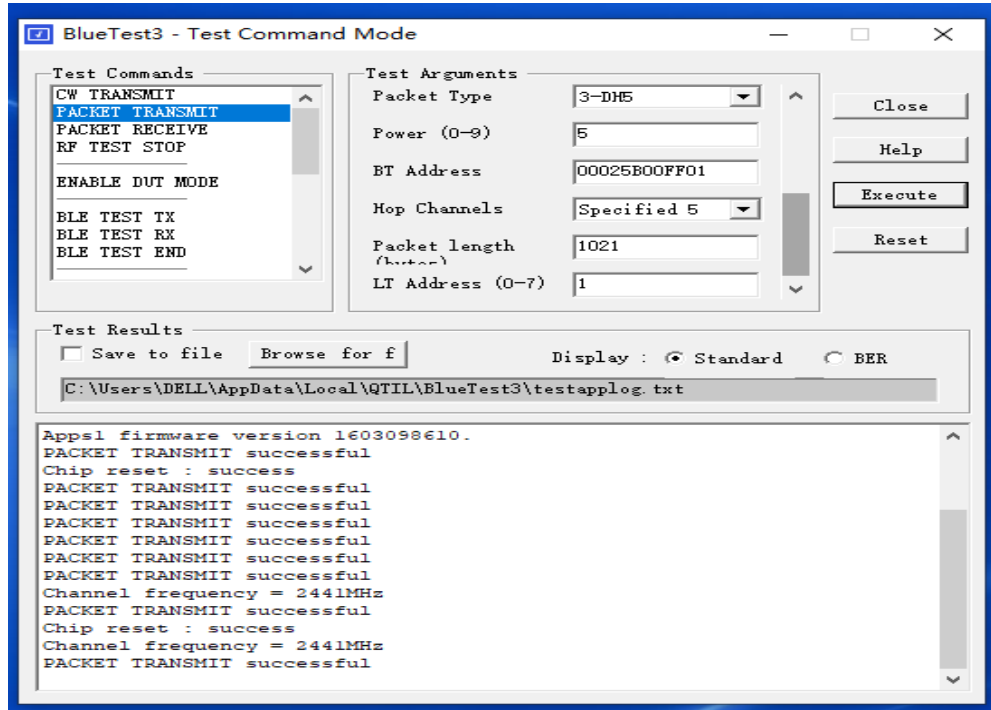

Test Graphs of Occupied Bandwidth

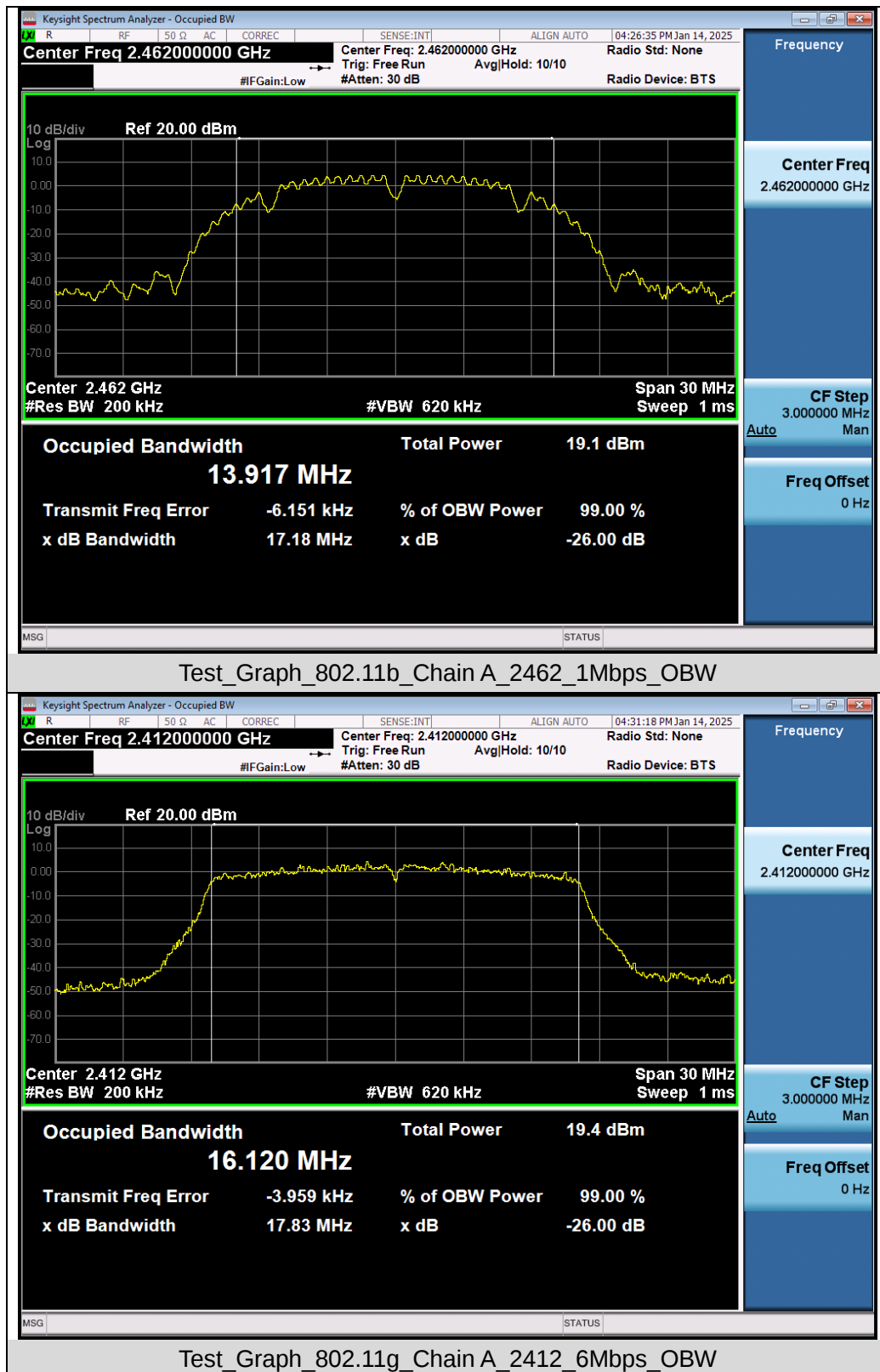


Test_Graph_802.11b_Chain A_2412_1Mbps_OBW

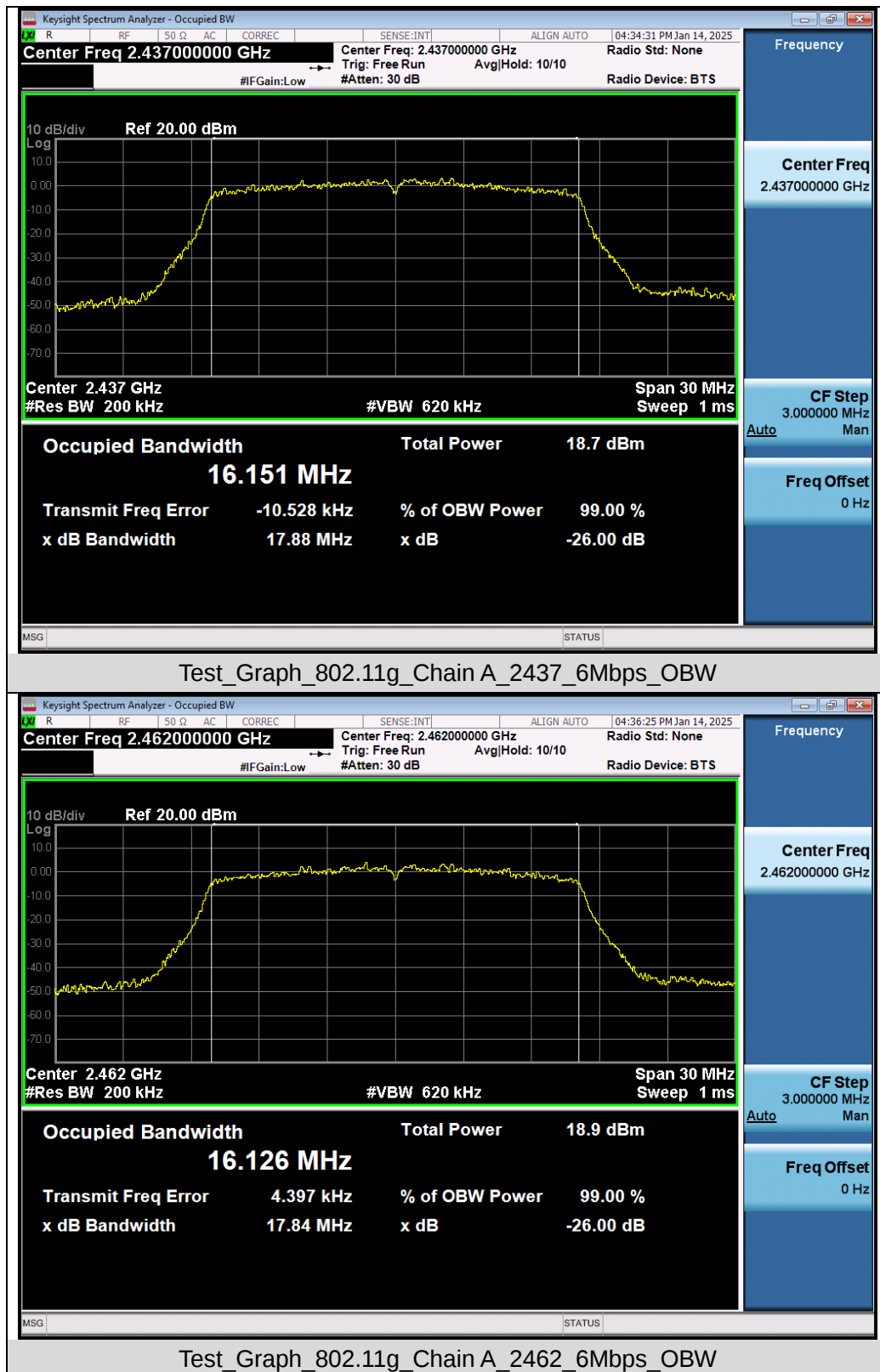


Test_Graph_802.11b_Chain A_2437_1Mbps_OBW

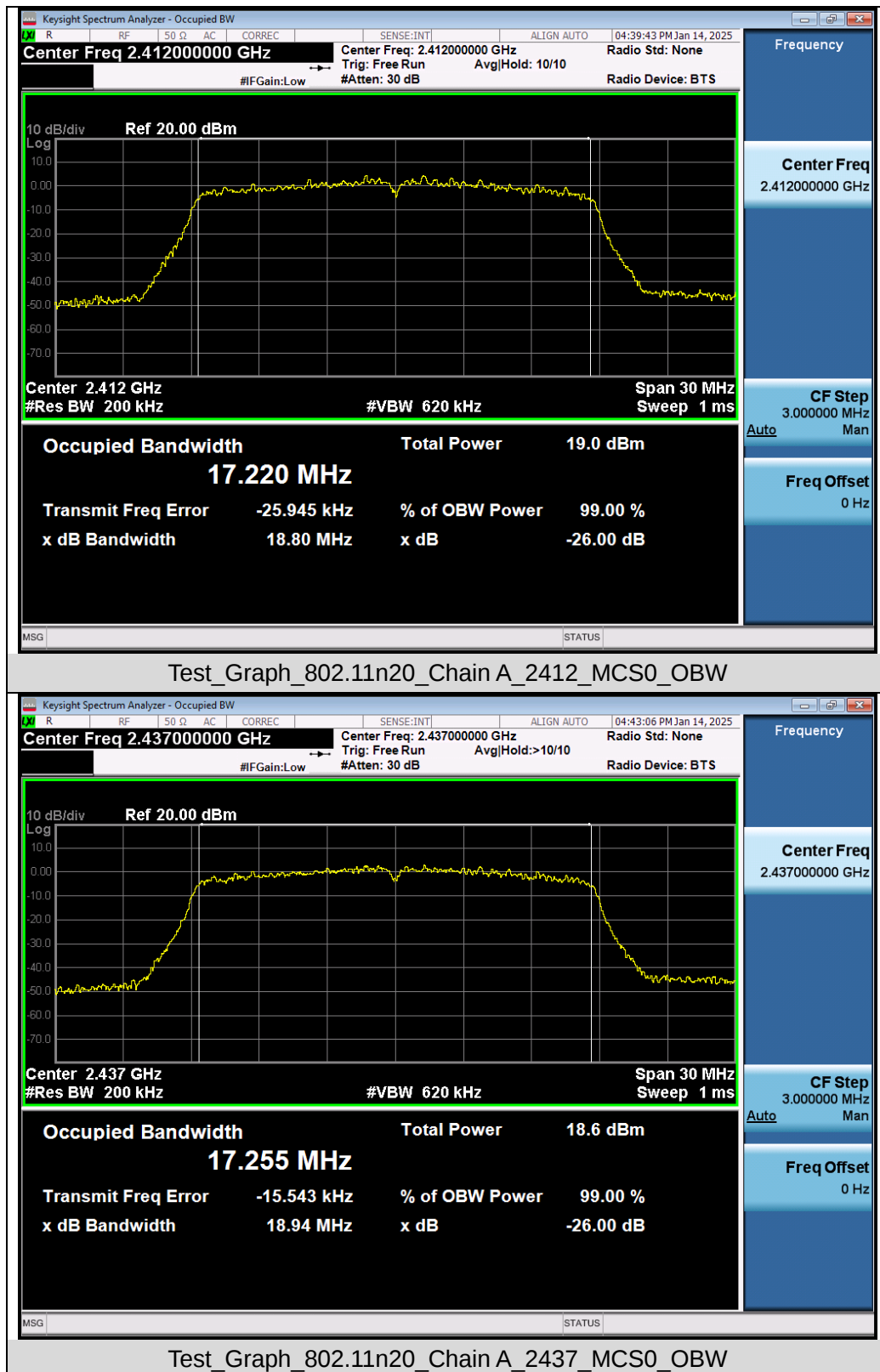
