

Federal Communication Commission Interference Statement

The OEM integrator has to be aware not to provide information to the end user regarding how to install or remove this RF module in the user's manual of the end product which integrates this module.

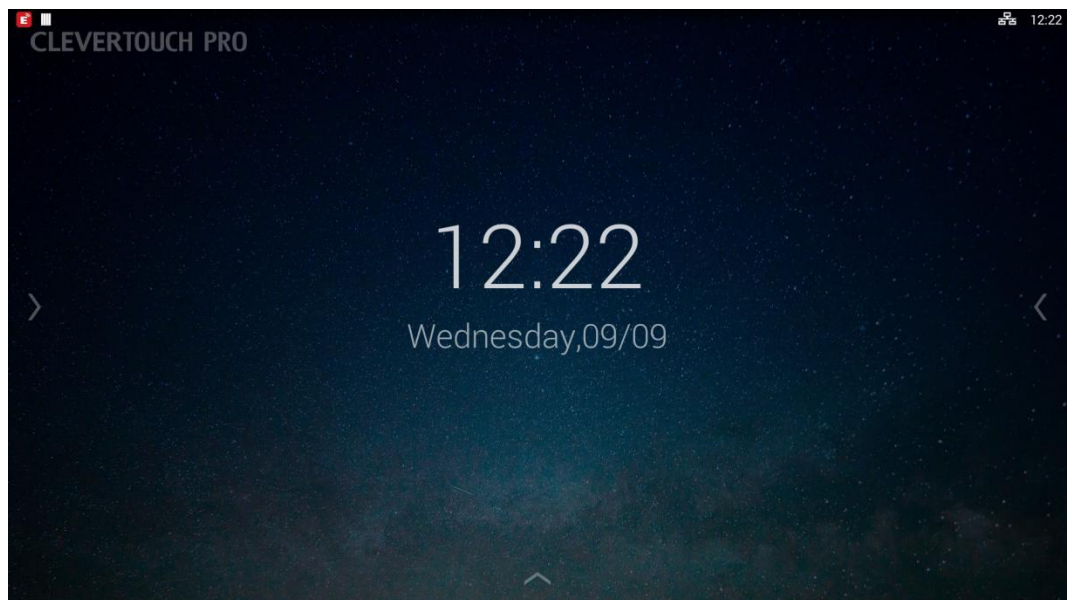
1 Software Description

2 Use Introduction

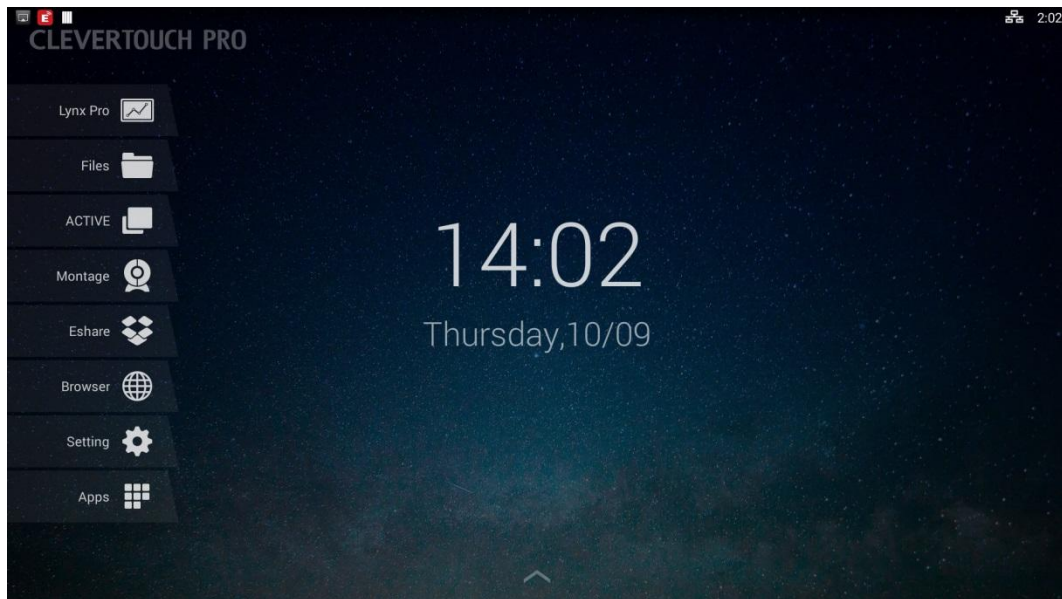
Open meeting machine into the main interface, as the picture 2-1 shows.

- upper right corner of the page displays the current network connection status and time, network connection status is divided into two kinds of wired networks and wireless networks, the current state of the icon shows the wired network.

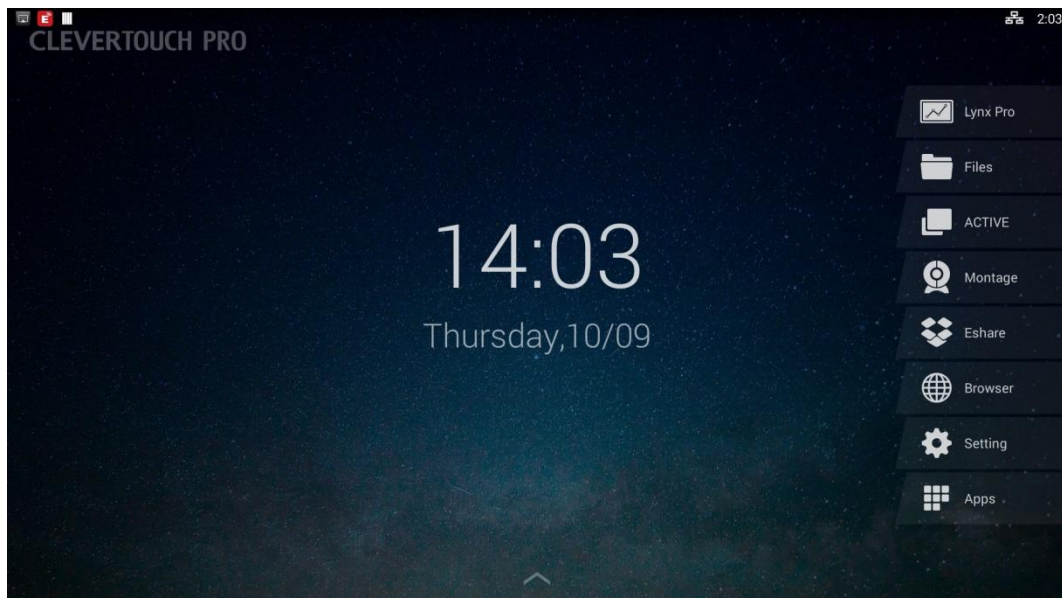


2-1 Main interface

2.2 Files

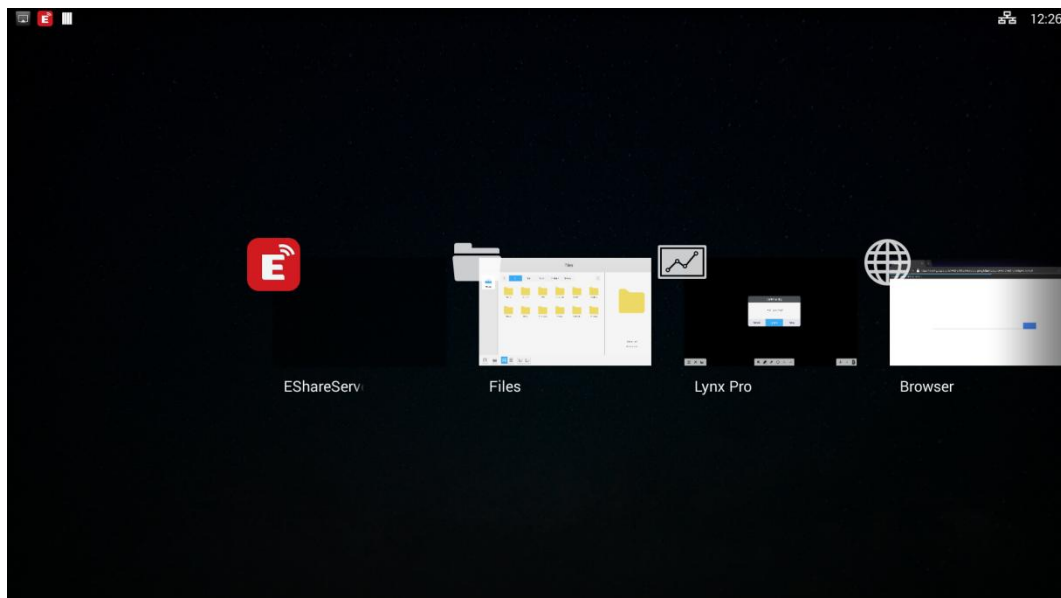


Click  on the main interface, you can enter the files of the system. And then you can manipulate files, Such as opening files, manage folders, etc.

2.7 Setting

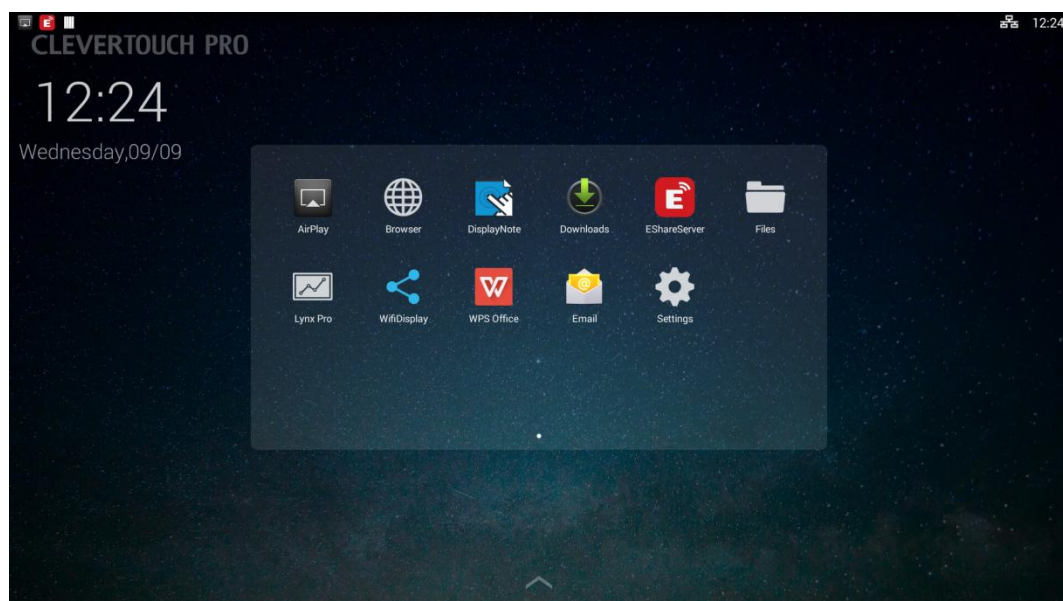


Click  on the main interface into the page of setting the system.

2.8 Apps



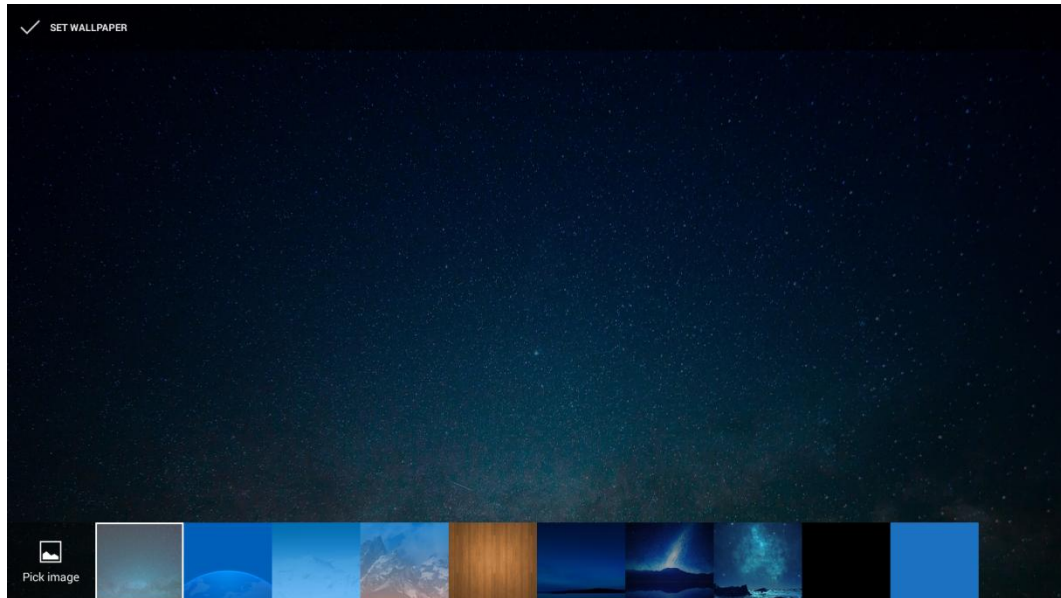
Click  on the main interface into the page of apps, as the picture 2-8-1 shows.

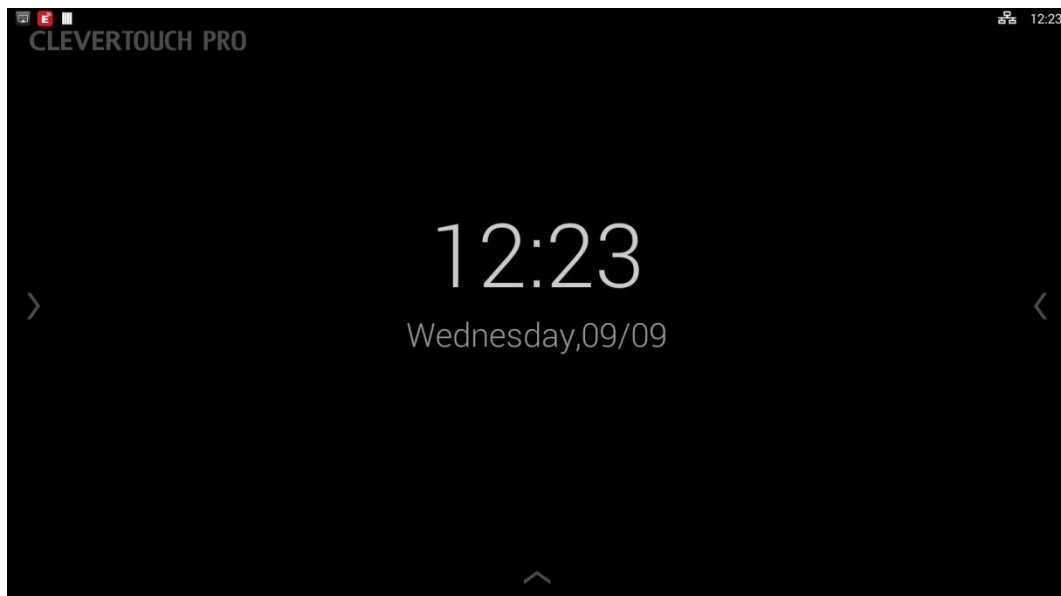
2.9 Switching desktop background
