


Installation


Step 1.

• Mirror Stem jointed with the Bottom Base;




• Mounting the Nut, Screw to the Bottom Base.





Charging Mirror

Charging Devices

Mirror MUST be connected to power for USB charging from the unit.

Removable Detail Mirror


