• at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1.31 x 10-2 f 0.6834 W (adjusted for tune-up tolerance), where f is in MHz;

The maximum antenna gain between the two antennas is 2.2 dBi

The max time-averaged EIRP per 2.0 above is $1.31 \times 10-2 \times 2405^{0.6834}$ (W) = 2.679W = 2679 mW.

The power density at 20cm corresponding to 2679 mW EIRP is N/(4 x π x d²) or 2679/(4* π *20²) = 0.533 mW/CM²
