3. The modular transmitter must have its own power supply regulation.	The main chip CYW20706 has the power supply regulation.
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The CYBT-333047-02; CYBT-333032-02 meets the FCC antenna requirements. It is an external antenna, Please see internal photo.pdf
