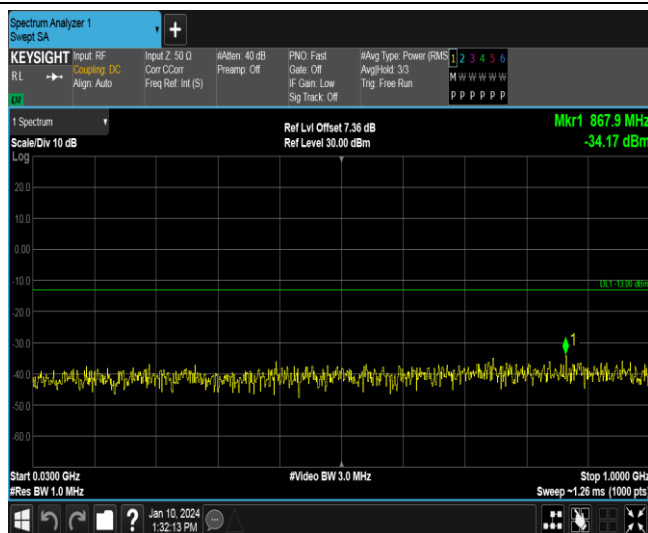
Band4-1.4MHz-QPSK-19957-1RB#0-Range2:1000~20000MHz



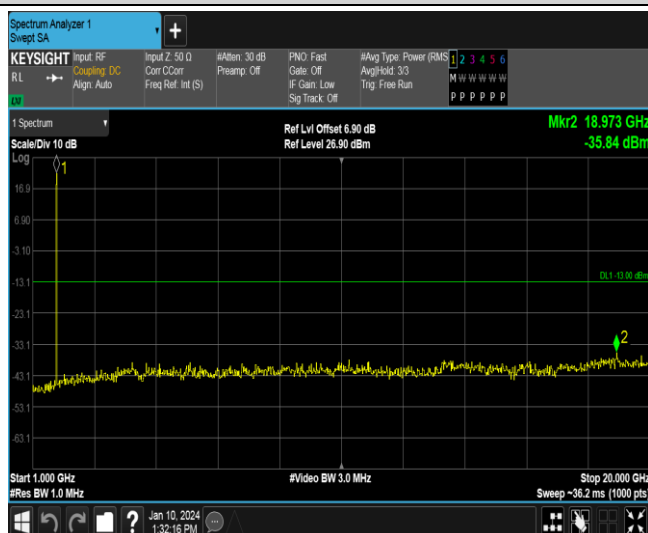

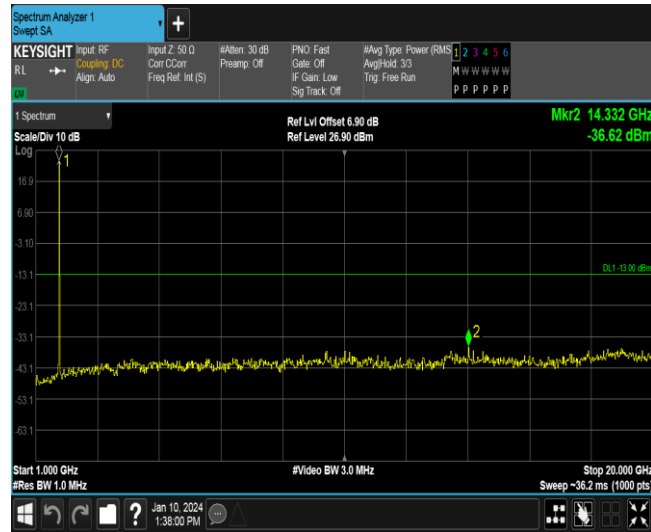


Band4-10MHz-16QAM-20175-1RB#0-Range1:30~1000MHz

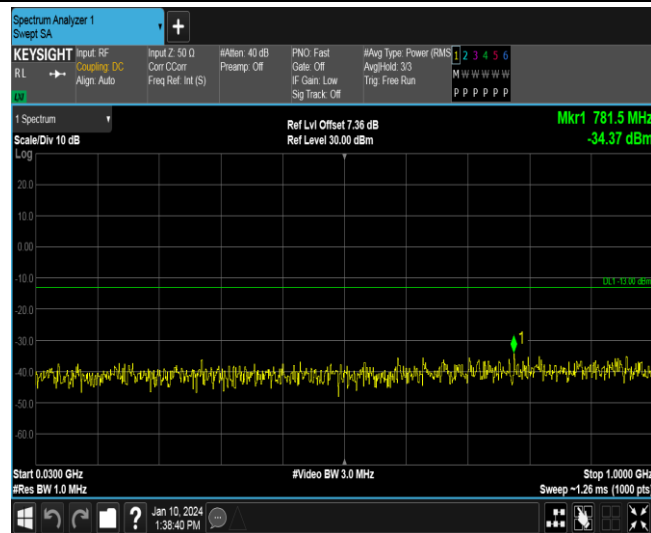

Band4-15MHz-QPSK-20025-1RB#0-Range1:30~1000MHz

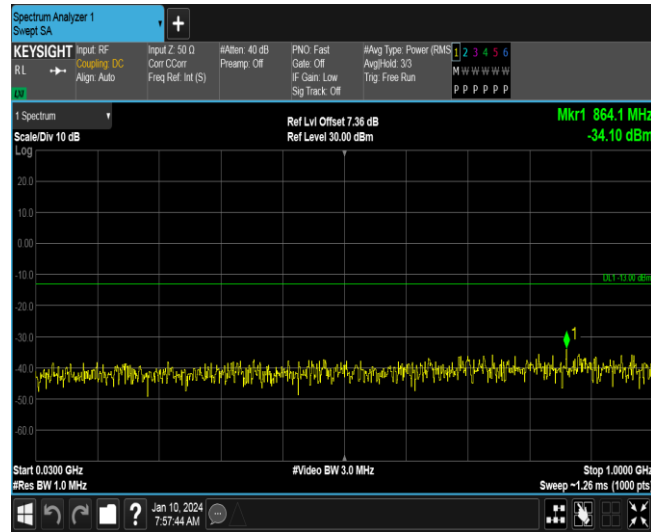


Band4-15MHz-QPSK-20025-1RB#0-Range2:1000~20000MHz

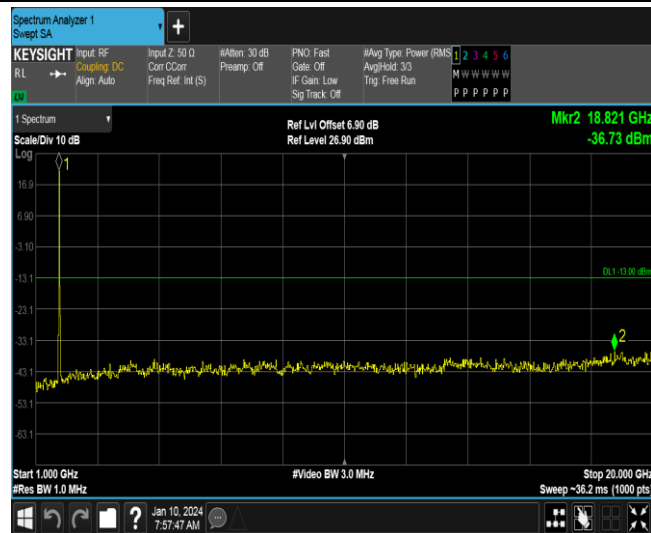
