

Photograph of the tissue simulant fluid liquid depth (Body)






Fig.2.1 Fig.2.2




Fig.3 EUT Lap-held mode to flat phantom






Fig.5 EUT Left side to flat phantom




Fig.8 Antenna position of EUT (Back view)
