



## 2.5 EUT Operation Test Setup

For Bluetooth function, programmed RF utility, "QRCT" installed in the notebook make the EUT provide functions like channel selection and power level for continuous transmitting and receiving signals.

## 2.6 Measurement Results Explanation Example

#### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

#### Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB).



- Set to the maximum power setting and enable the EUT transmit continuously. 3.
- 4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. Set the Video bandwidth (VBW) = 300 kHz. In order to make an accurate measurement. The 6 dB bandwidth must be greater than 500 kHz.
- 5. For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) is set 30kHz and set the Video bandwidth (VBW) = 100kHz.



#### 6 dB Bandwidth Plot on Channel 00









## 3.2 Peak Output Power Measurement

## 3.2.1 Limit of Peak Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.







#### PSD 100kHz Plot on Channel 00







#### **PSD 3kHz Plot on Channel 00**



## Low Band Edge Plot on Channel 00





# Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 00



# Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 00





## Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 19



# Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 19





#### For radiated emissions below 30MHz




#### For radiated emissions from 30MHz to 1GHz







## 3.7 Antenna Requirements

## 3.7.1 Standard Applicable
