
#### System upgrade:

Projector model/System version/ UI version/MCU version/ROM/RAM /Eth Mac.


Note: It is not recommended to upgrade built-in APP, which may cause incompatibility problems.






### Online Upgrade



- 3, If it shows the lastest version of software then the system is up to date.






### Switch to bluetooth speaker mode:
