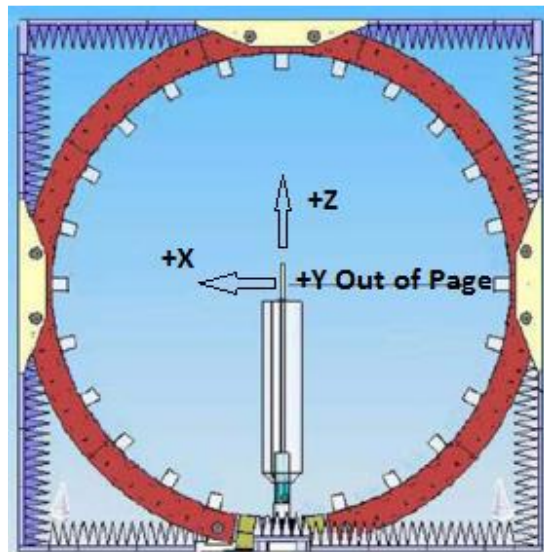
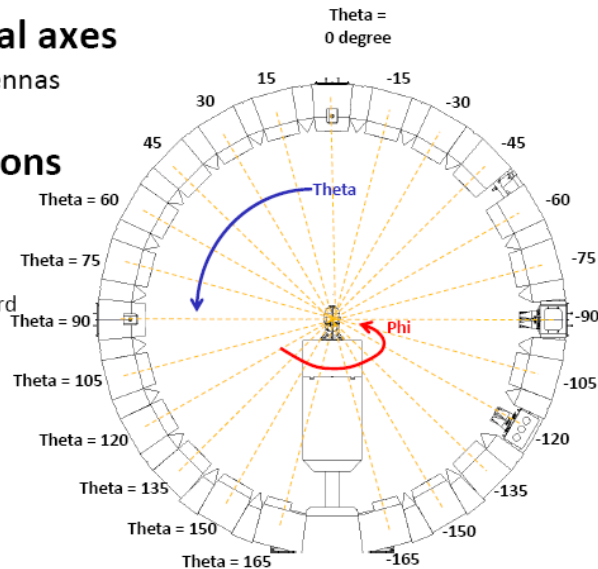
### 5.1 Test Setup – Chamber Coordinate System
