(b) physical damage, cracks, dents or scratches caused by a drop or by external forces occurring in or on the product including but not limited to the cover, display, camera lenses, buttons (unless specified otherwise by the Manufacturer under certain conditions); (c) using your Product with, or connecting it to, any product, accessory, software, or service not manufactured or supplied by Manufacturer; (d) any products combined with your Product by a third party;

(e) damage or errors caused by hacking, cracking, viruses, or other malware, or by unauthorized access to services, accounts, compute systems, or networks;
