


Installation Tips



- Install your lights within Wi-Fi range
- When installing on a rope or cable, hook every *other* bulb onto the rope/cable. Leaving more than two consecutive bulbs unsupported may lead to sagging over time.
- Do not nail through the lights wire. Instead, hang the lights using the eyehole above each bulb.
- Avoid placing the light string over sharp edges as this could damage the wire.
- Ensure control box is installed vertically.

TIP! Use your phone's Wi-Fi to determine if you will have enough signal where you plan on installing your lights.

Installation



1. Remove protective film from each bulb.
2. Thread the rope through the eyeholes above each bulb.
3. Affix both ends of the rope to a pole, post, or wall.
4. Connect the control box to the string light and tighten the screw connector.
5. Mount the control box **vertically** using included screws. When mounting to a rounded surface, use cable ties to hold in place.



Extending Multiple Cafe Light Strings



1. Connect up to 96ft of Cafe Light strings. To connect, unscrew the cap at the end of the cable and insert the end of the additional light string. Tighten the screw cap.

2. Repeat to connect additional light strings.

3. Keep the power supplies for connected string lights in a safe place for future use.
