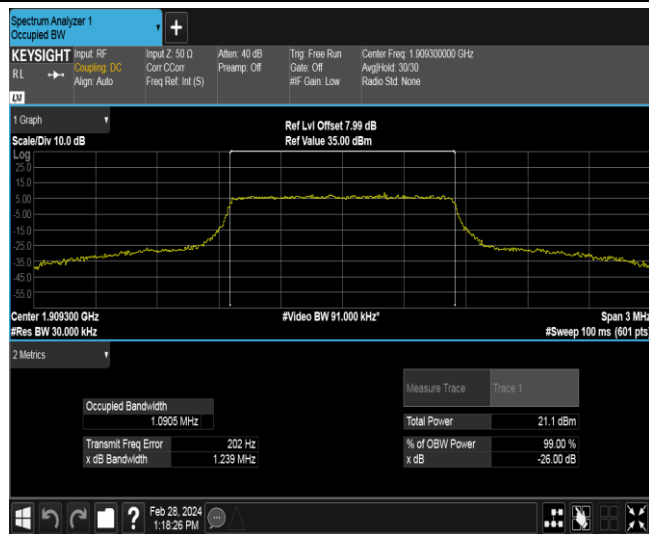


Band2-1.4MHz-QPSK-18900-6RB#0
