Diagram of Measurement Configuration for Radiation Test (Above 1GHz)

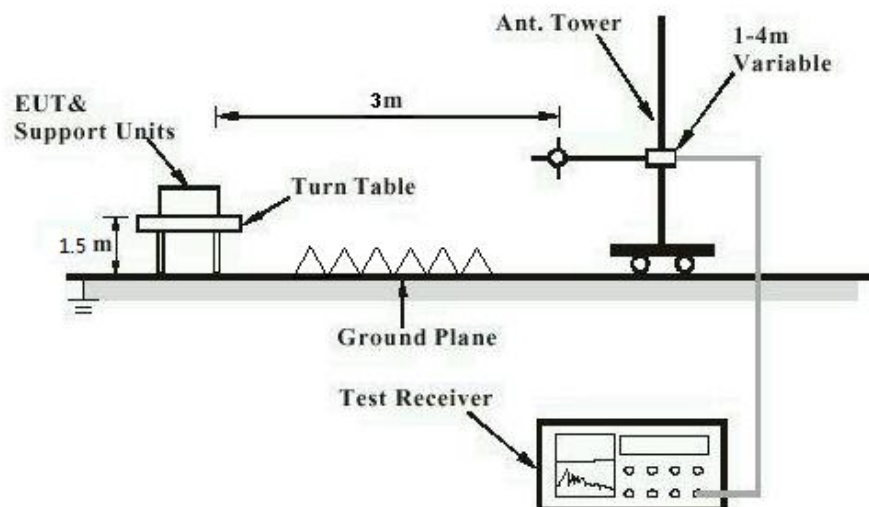
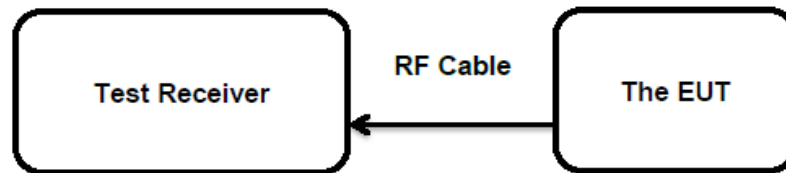


Diagram of Measurement Configuration for Conducted Transmitter Measurement

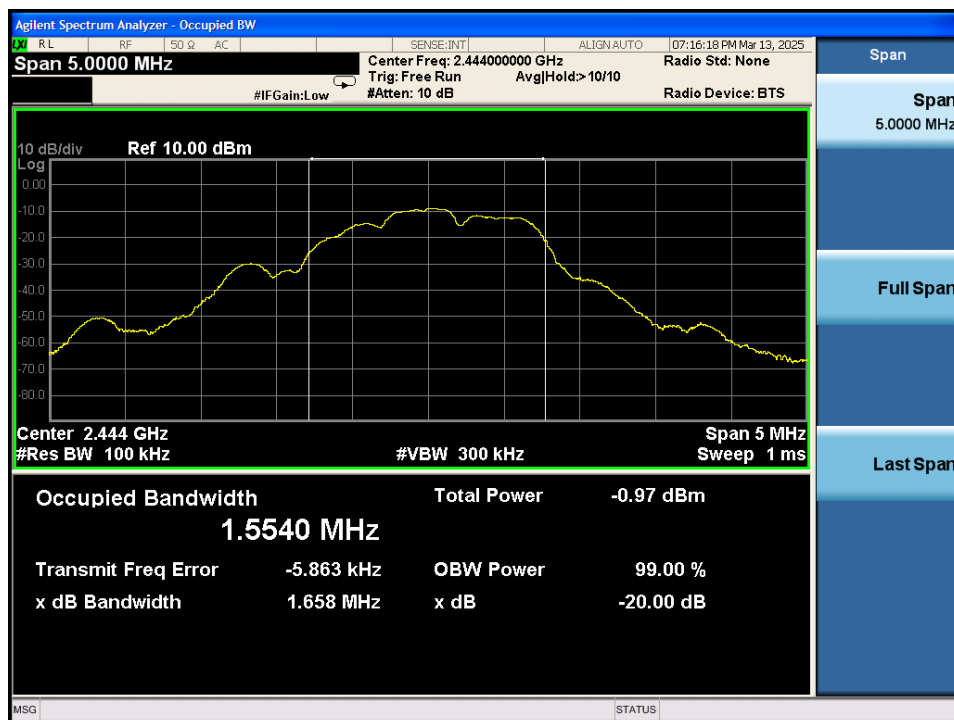
