Band2-20MHz-QPSK-18900-100RB#0

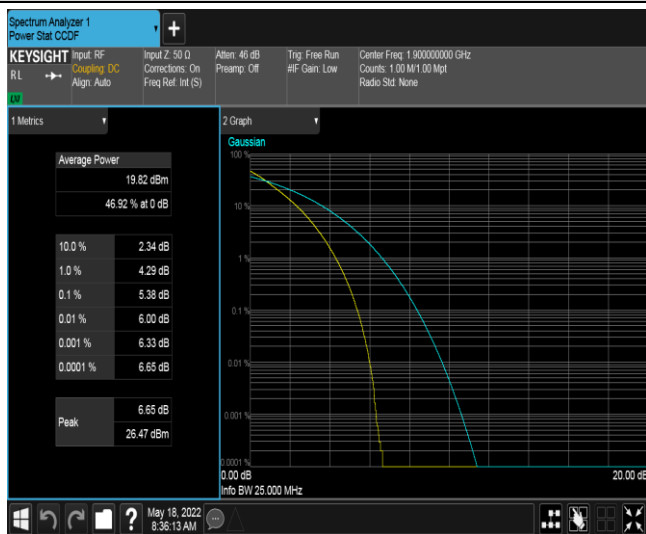


Band2-20MHz-QPSK-19100-1RB#0

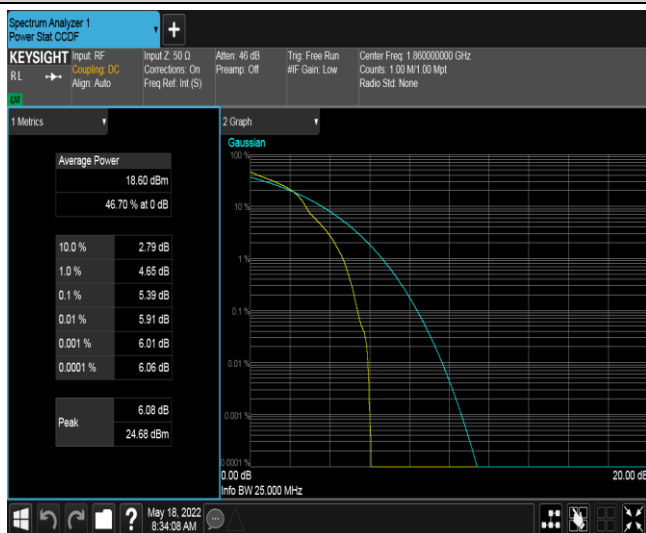
