**To Whom It May Concern,**

This document serves as an official attestation that the **Sigyn MKII (SH-00001)**, manufactured by **Axon Enterprise Inc.**, complies with all conditions and limitations set forth in the **Federal Communications Commission (FCC) Waiver Order DA 24-1216**, granted on **December 5, 2024**, to Axon Enterprise, Inc.

Specifically, we certify that:

**1. Usage Scope:**

The device is designed and intended solely for emergency and safety-of-life surveillance operations by authorized law enforcement agencies. It shall not be used for routine monitoring or general surveillance purposes.

**2. Transmission Parameters:**

The device operates in the 5725–5850 MHz band using analog modulation on the following authorized channels:

- SH23: 5729.5 – 5734.5 MHz
- SH24: 5766.5 – 5771.5 MHz
- SH25: 5803.5 – 5808.5 MHz
- SH26: 5840.5 – 5845.5 MHz

The radio prioritizes non-overlapping channels SH23 and SH26.

**3. Technical Compliance:**

- The device operates under the modified power limits permitted by the waiver:
  - Max conducted average output power: 0.563 Watts

- Power spectral density: 6.5 dBm/3kHz
- The device may exceed the OOB limits in §15.247(d) by no more than 6 dB.

4. **Power Source & Deployment:**

The device is battery-powered only and is not intended for permanent or fixed installations.

5. **Sales and Distribution:**

- The device is sold and distributed **exclusively to law enforcement agencies** eligible under **47 CFR §90.20**.
- Sales are limited in accordance with the waiver as follows:
  - Maximum 2,000 units in the first year
  - Maximum 4,000 units per year in the following two years
  - Not to exceed a total of 10,000 units over the 3-year waiver period
- No sales or marketing will occur beyond this quota or after the waiver expires.

6. **Military Coordination:**

- Patrick Space Force Base, FL
- Vandenberg Space Force Base, CA

7. **Waiver Validity:**

This waiver is valid for **three (3) years from December 5, 2024**, and expires automatically at the end of that period. Existing devices may continue to operate under the waiver's conditions.
