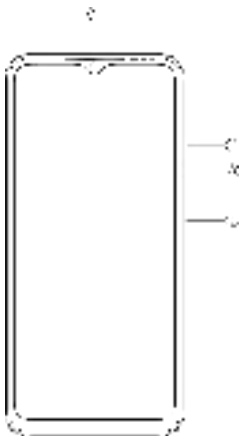

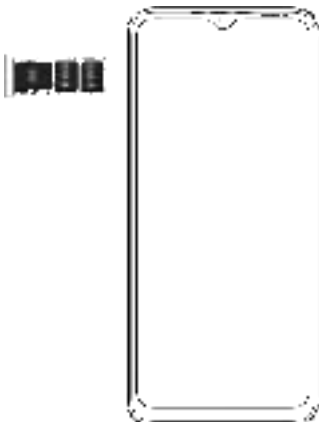
Know your phone
