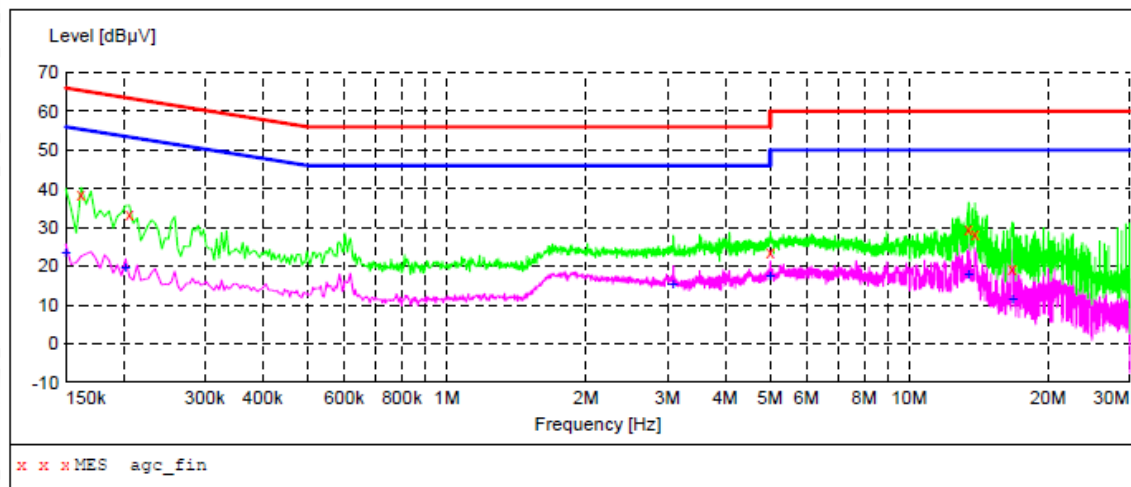

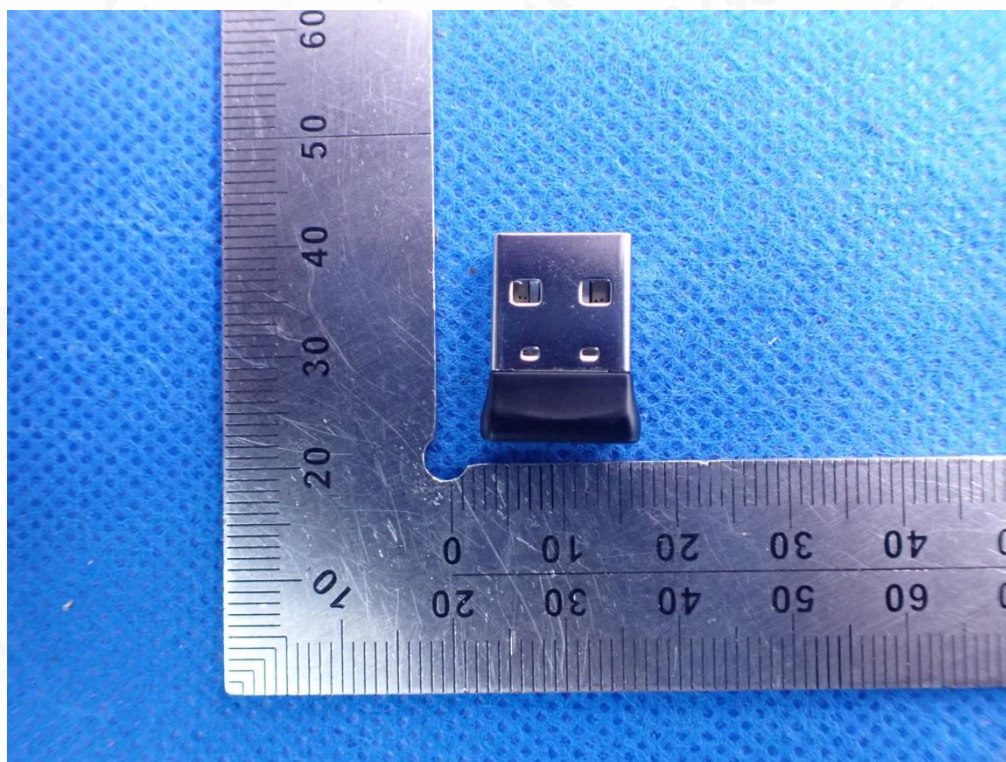

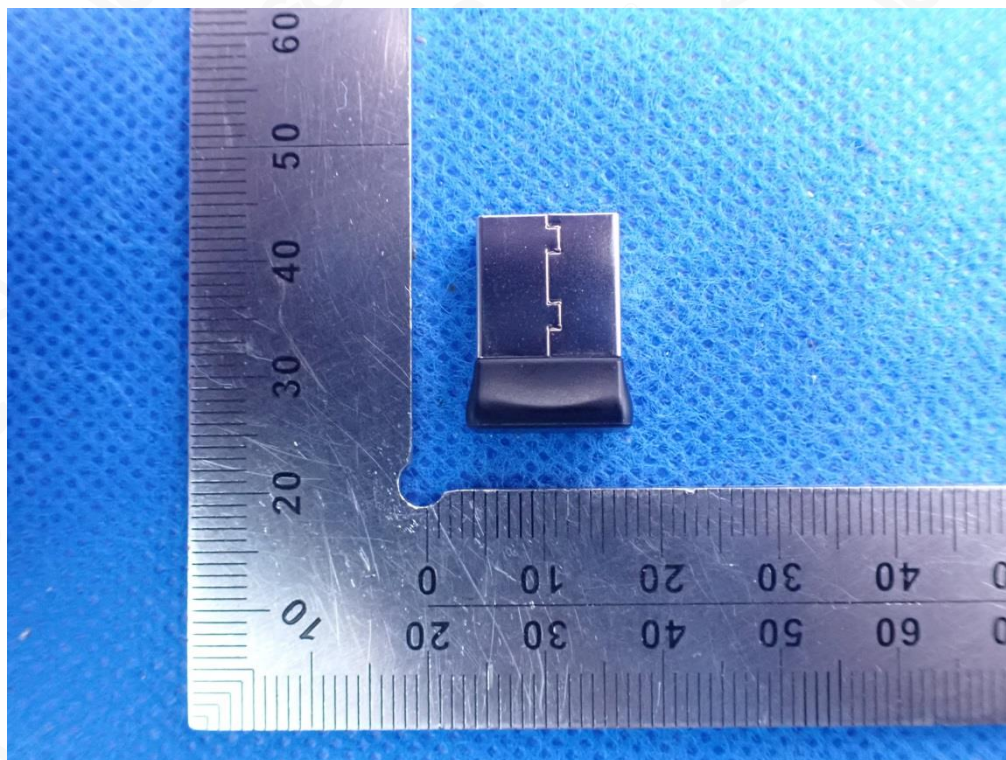

### BOTTOM VIEW OF EUT



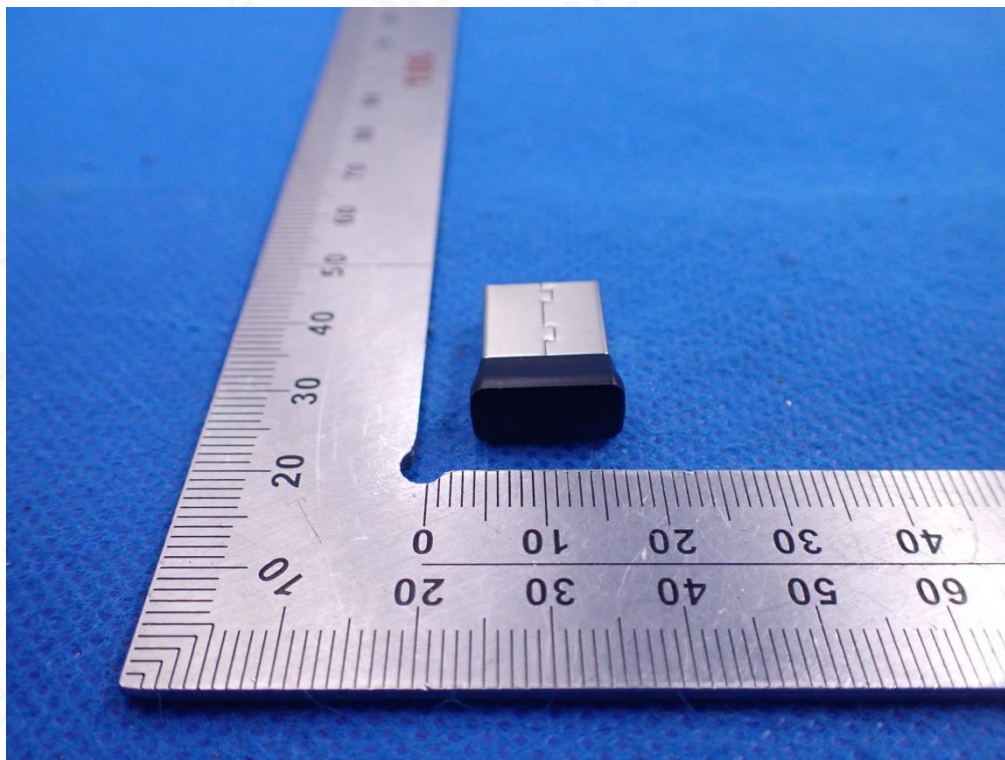

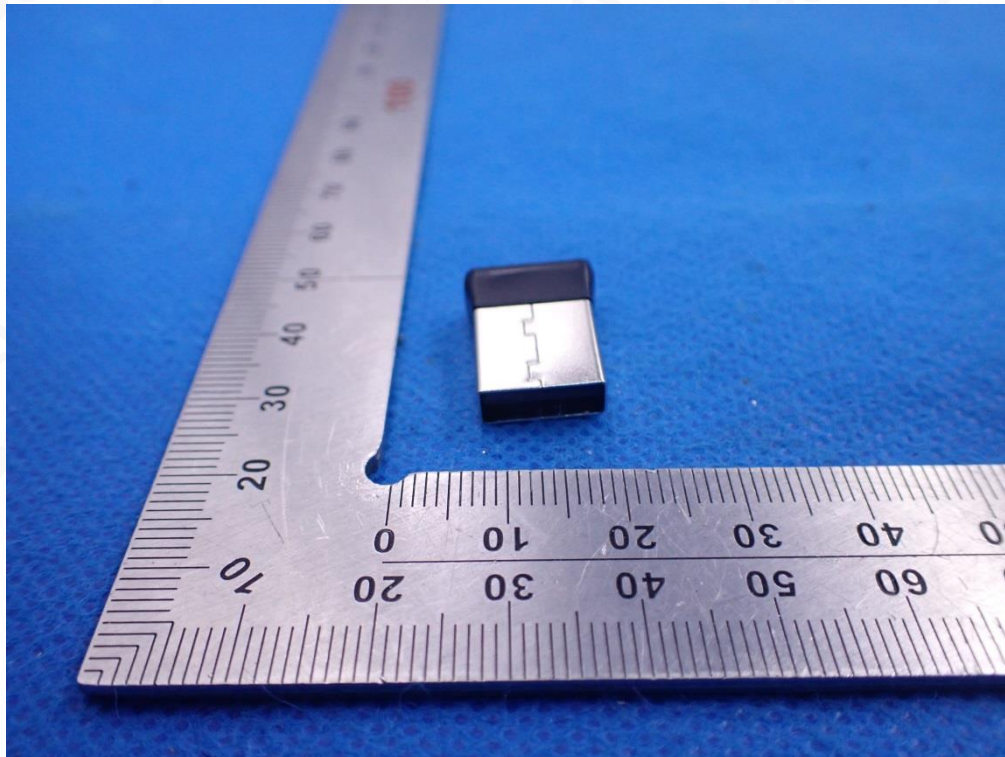




FRONT VIEW OF EUT



BACK VIEW OF EUT



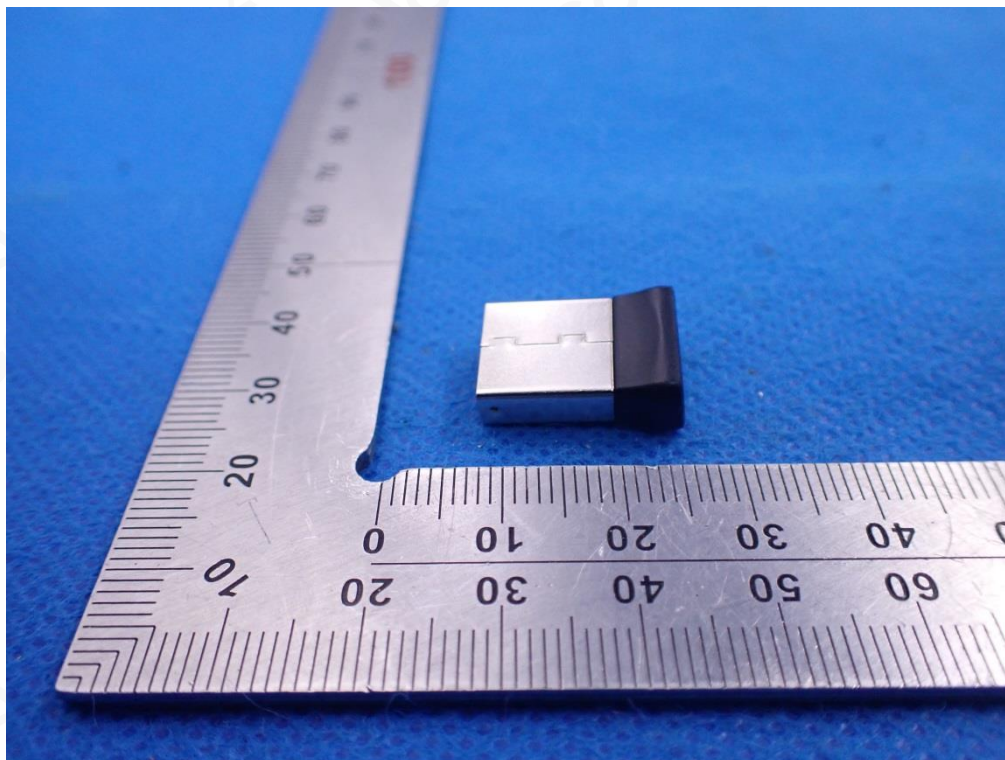

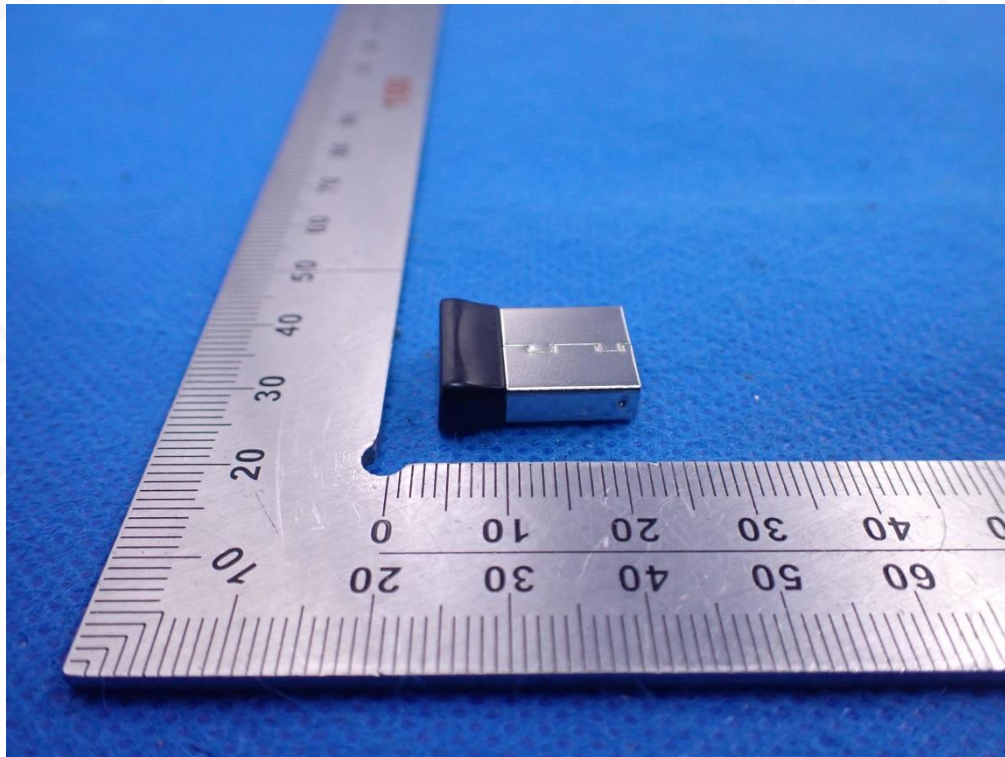




LEFT VIEW OF EUT



RIGHT VIEW OF EUT



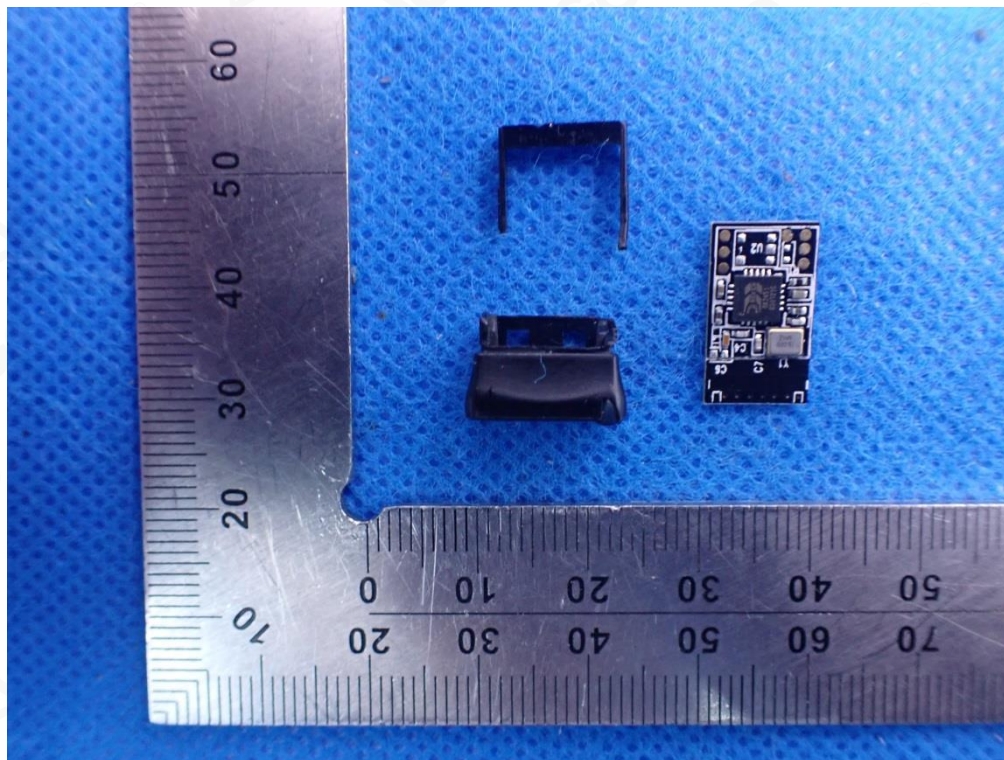

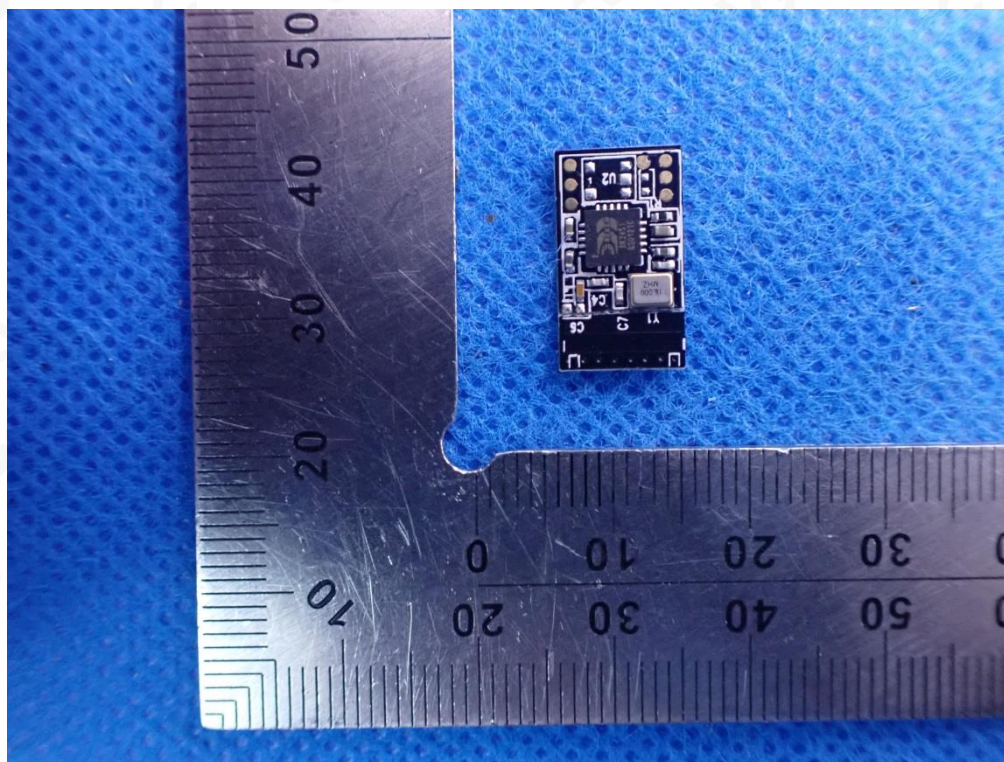

INTERNAL VIEW-1 OF EUT



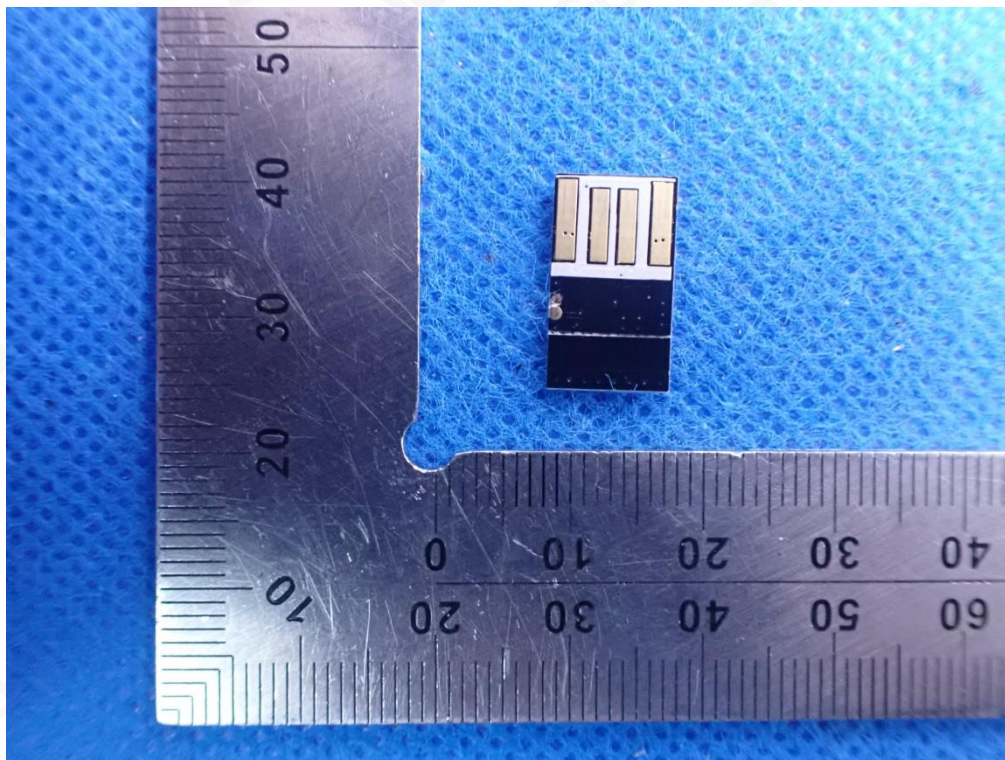

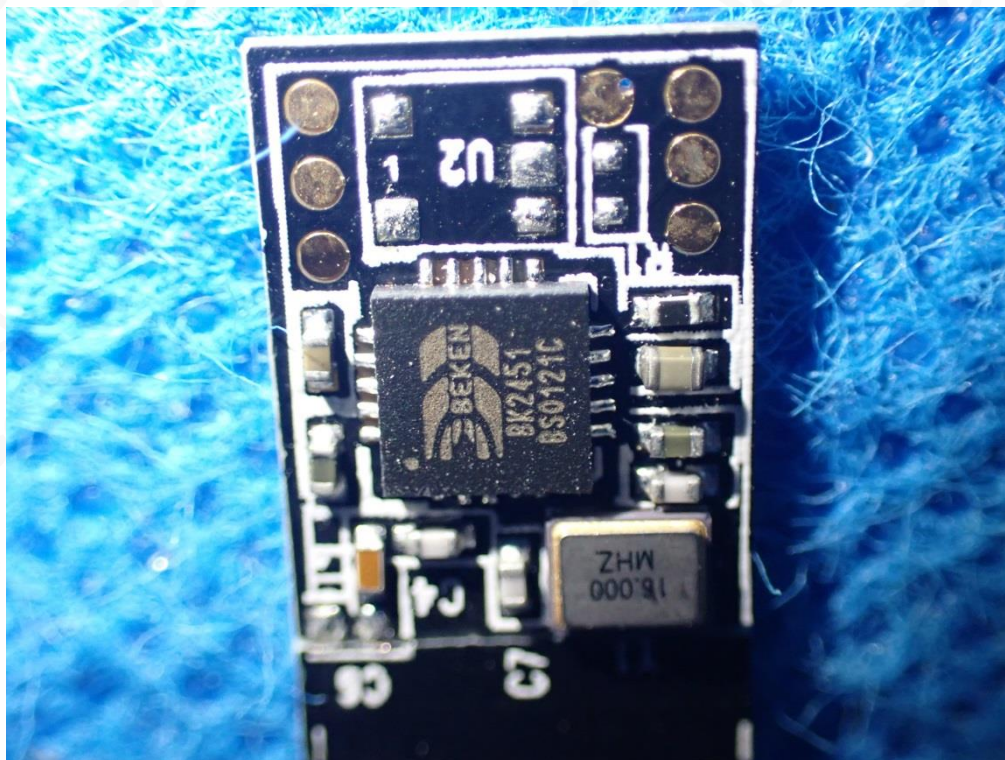




INTERNAL VIEW-2 OF EUT



INTERNAL VIEW-3 OF EUT



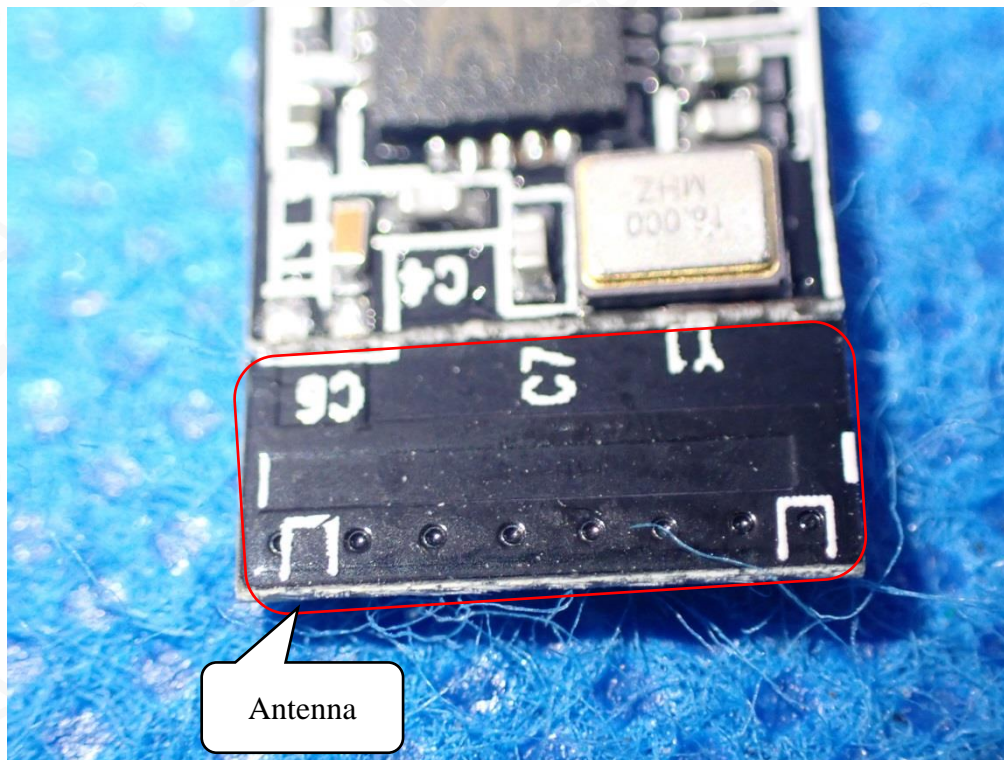
