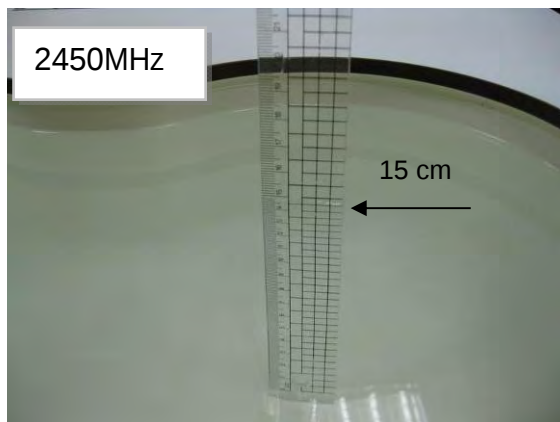

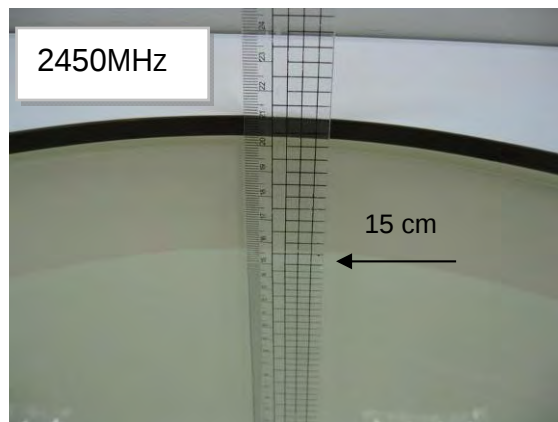

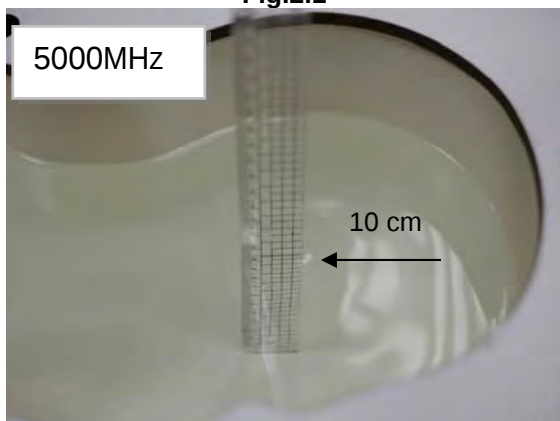

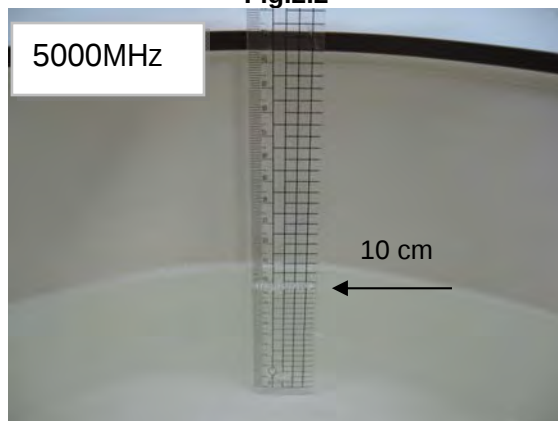

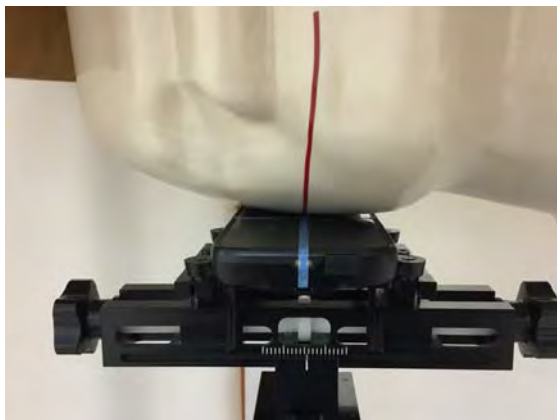


Fig.3 Right Head Section / Cheek-Touch Position

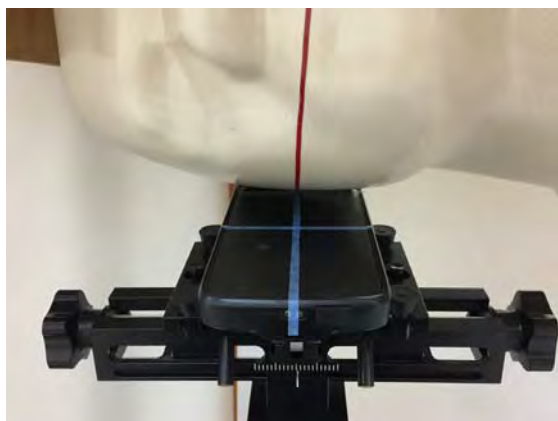
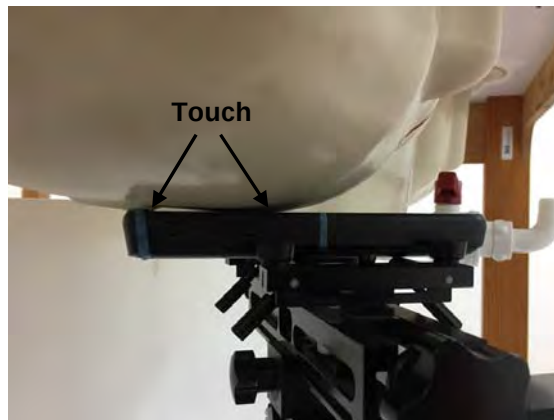


Fig.4 Right Head Section / Ear-Tilt Position(15°)

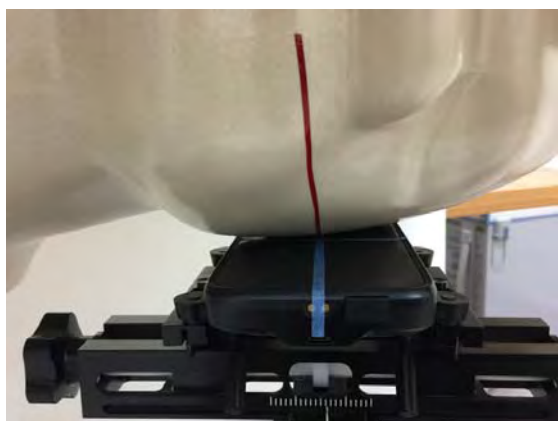
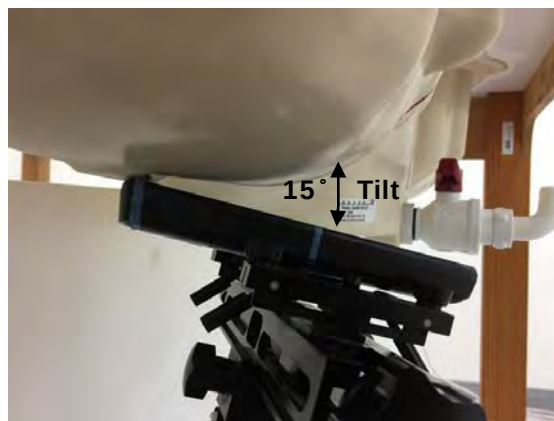
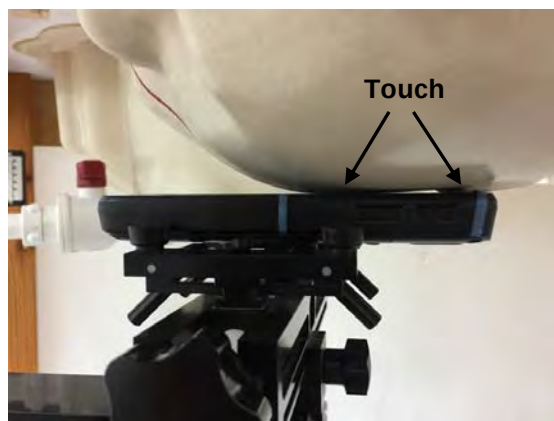


Fig.5 Left Head Section / Cheek-Touch Position

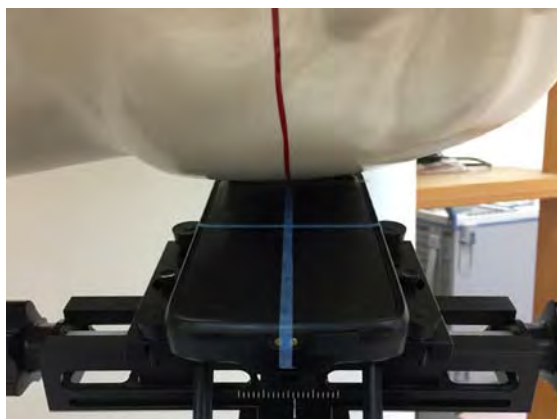


Fig.6 Left Head Section / Ear-Tilt Position(15°)

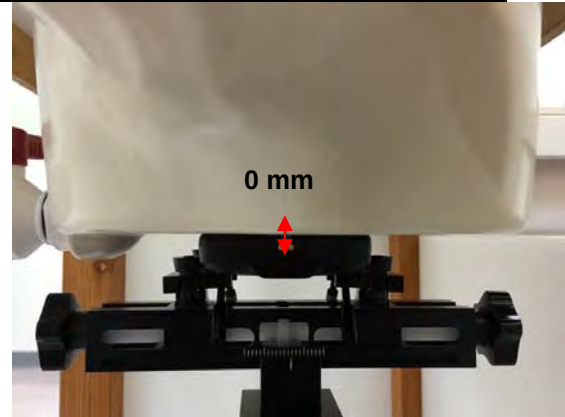


Fig.10 EUT Back side to flat phantom

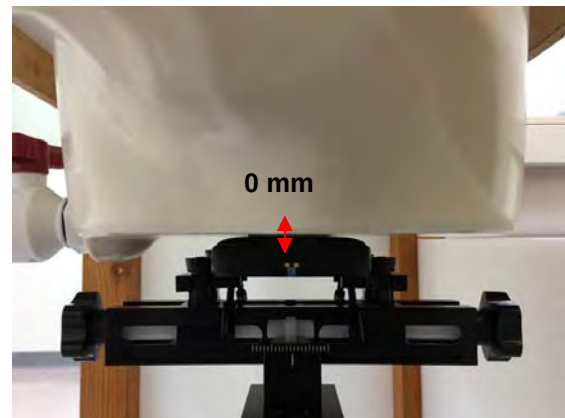
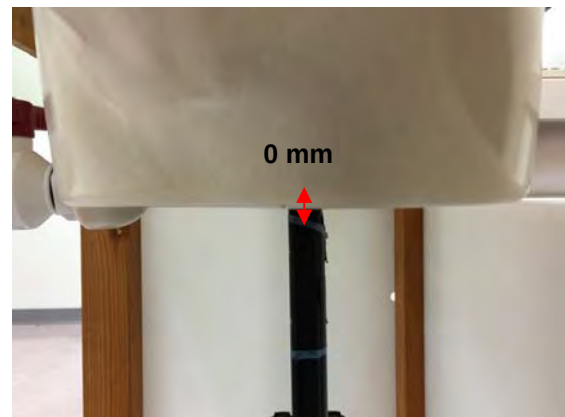


Fig.11 EUT Top side to flat phantom

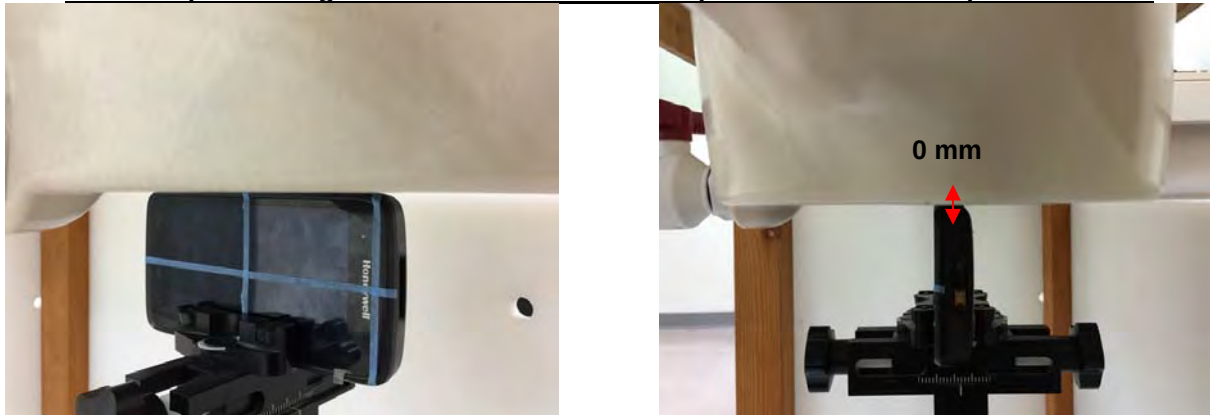


Fig.12 EUT Left side to flat phantom

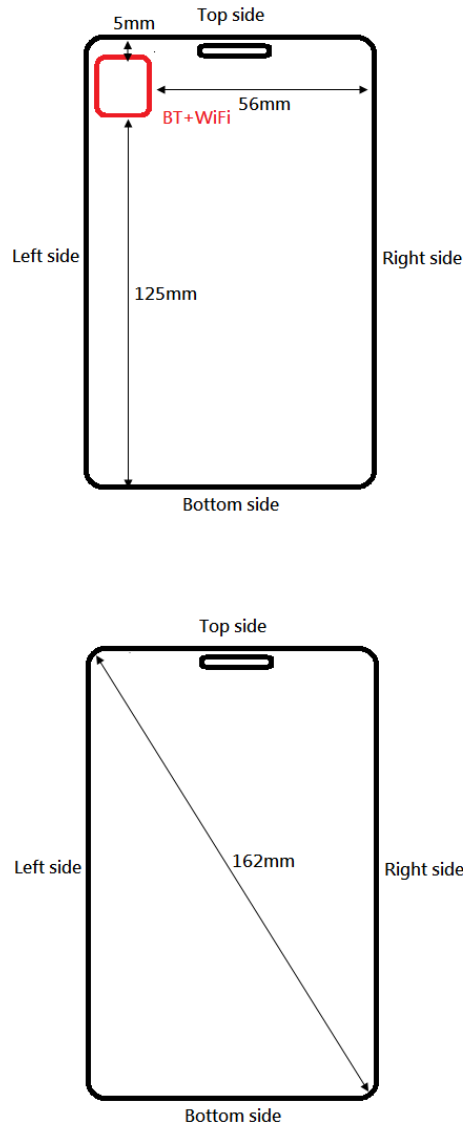


Fig.15 Antenna location and dimensional size
